RESOLUTION R-2023-0621**

**RESOLUTION AUTHORIZING THE CITY OF WEST ALLIS TO ENTER INTO
AGREEMENT WITH TES HISTORICAL CONSULTING, LLC AS CONSULTANT
TO NOMINATE THREE PROPERTIES TO THE NATIONAL REGISTER OF
HISTORIC PLACES**

WHEREAS, the City of West Allis recognizes the importance of preserving and recognizing the many historical and significant properties in West Allis; and,

WHEREAS, City staff submitted an application in December 2022 to request funding from the Wisconsin State Historic Preservation Office to assist in nominating properties to the National Register of Historic Places; and,

WHEREAS, In February 2023, the State Historic Preservation Office notified City staff that the City of West Allis was awarded \$14,000 to nominate three properties to the National Register of Historic Places; and,

WHEREAS, at the May 16, 2023, Common Council Meeting, Council authorized the City of West Allis to accept the Federal Historic Preservation Fund subgrant as referenced in R-2023-0380; and,

WHEREAS, the three properties that are selected to be nominated are two residential properties at 12233 W Cleveland Ave. and 2479 S Green Links Dr., along with Longfellow School at 2211 S 60th St.

WHEREAS, The City of West Allis has solicited two (2) proposals, through the request for proposal process, from licensed historical consulting firms interested in performing the work required to assist with the competition of the nomination application; and,

WHEREAS, After considering and scoring both consultants, City staff arrived at the conclusion that the proposal offered by tes Historical Consulting, LLC is best suited to the specific task of preparing all work required in order to nominate the selected properties; and,

NOW THEREFORE, BE IT RESOLVED, by the Common Council of the City of West Allis, that it hereby authorizes the City of West Allis to enter into agreement with tes Historical Consulting, LLC to provide consulting services for the City in order to nominate three properties to the National Register of Historic Places.

BE IT FURTHER RESOLVED that the necessary City Staff is hereby authorized and directed to take all other actions deemed necessary to effectuate the intent of this Resolution.
