The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of November 2010.

Incident reports:

Case 10-010325, 11/06/10 at 0039hrs. Johnny Hammers Tavern, 6300 W Lincoln Ave.

On the above date and time officers were called to Johnny Hammers Tavern for a report of a fight inside the tavern. A retired Sheriff's Deputy who was involved in the fight was the caller. The fight began over a pool game. Both parties involved were arrested but the charges were not processed at the District Attorney's Office.

Case 10-010495, 11/11/10 at 0132hrs. Larry Michaels Tavern, 8900 W Greenfield Ave.

On the above date and time officers responded to a call from the bar manager at Larry Michaels in regards to a problem with several customers in the tavern. Eventually one party involved was arrested for Disorderly Conduct. Two other parties involved were arrested for having warrants with other departments. One of those parties was also in possession of a small quantity of Marijuana, which he was cited for.

Case 10-010533, 11/11/10 at 2347hrs. Night Court Tavern, 7127 W National Ave.

On the above date and time officers responded to the alley behind Night Court for a disturbance between a female and male. The female was extremely intoxicated and had gotten into an altercation in the bar with another female patron. The male was able to get her out of the bar but she became disruptive outside wanting to get back into the bar. She was eventually arrested for Disorderly Conduct.

Call 10--053724, 11/21/10 at 0216hrs. Mario's, 1900 S 60 St.

On the above date and time officers of the West Allis Police Dept were monitoring the crowd leaving Mario's after being flagged down by a security officer from the bar. The party stated that several parties causing trouble at the bar had been asked to leave and he feared they would be coming back. For approx 20 minutes 5 officers monitored the area and the crowd leaving the area. The parties never returned but officers observed intoxicated patrons walking into the roadway causing traffic problems. Parties were loud and shouting profanities at each other and at the officers. Officers intervened in several skirmishes before all parties eventually dispersed.

Case 10-010350, 11/06/10 at 2350hrs. The Colony, 5801 W Beloit Rd.

On the above date and time officers were called by a security guard of the Colony Bar in regards to a party causing a disturbance and threatening to shoot patrons. The alleged offender had fled the scene. While on the scene officers observed the party down the block who ran to his auto and led officers on a brief chase before they broke it off. The party was eventually arrested and charged with Eluding.

Tobacco and Alcohol Compliance checks;

No checks for the month.

Violation of Wisconsin Clean Air Act Smoking Ban;

There were six reported violation documented over the last 3 months.

Call 10-042913, 09/11/10 at 1412hrs. Second Chance Saloon, 5906 W Burnham St.

On the above date and time an officer responded to a call at the Second Chance for a complaint of patrons smoking in the bar. A patron of the bar was issued a warning citation and the bartender on duty and owner of the bar were both warned.

Case 10-009955, 09/22/10 at 2100hrs. Network Tavern, 9541 W Cleveland Ave.

On the above date and time an official from the Wisconsin Tobacco Prevention and Control Program called to report parties smoking at the Network Tavern. Due to several other complaints from the tavern the owner was cited for the violation.

Call 10-050443, 10/29/10 at 2216hrs. Sarge's Corner, 1979 S 54 St.

On the above date and time an official from the Wisconsin Tobacco Prevention and Control Program called to report she observed the bartender and a patron smoking at Sarge's Corner. A warning citation was issued to the owner of the tavern.

Case 10-010445, 11/09/10 at 1835hrs. Barnek's 7411 W Becher St.

On the above date and time while attempting to issue the owner of Barnek's a warning citation for parties smoking in the tavern on an earlier date, two women were observed smoking in the bar. They were both cited for violating the Clean Air Act Smoking Ban.


Case 10-010748, 11/18/10 at 1854hrs. Network Tavern, 9541 W Cleveland Ave.

On the above date and time officers observed two parties smoking in the Network Tavern. Both parties were cited along with the owner of the tavern.

Case 10-011026, 11/27/10 at 1839hrs Dog House Tavern, 1641 S 68 St.

On the above date and time while doing tavern checks officers observed two patrons smoking in the bar. Both were issued citations for violating the Clean Air Act Smoking Ban. The owner was issued a warning citation for the incident.
