

NARRATIVE

Officer Foy reports...

DISPATCH TO CALL/ARRIVAL ON SCENE

On 11/23/14 at 0303hrs officers responded to Stallis Palace, 8812 W Greenfield Ave for a report of a male that slashed a tire on a vehicle. I arrived on scene and briefly spoke with an employee who advised his truck tire had been slashed. The male, Matthew Jaskulski, advised he had attempted to catch the male but the male took off running. Jaskulski advised that the male's female friend was still inside of the bar. I walked in and made contact with the female, identified by his WI DL as Cayla N. Clark.

STATEMENT OF OFFENDER - CAYLA CLARK

I spoke with Cayla Clark in relation to the incident. Clark stated she was at the bar with friends earlier in the night when several of her friends began to leave

after a verbal altercation. Clark stated she came to the bar with Brad Hoppe as he is going away to prison for several years. Clark stated she stayed the bar with the remaining person in the group, whom she identified as Matt Hoppe, cousin of Brad. Clark stated Matt resides in West Bend but Brad lives somewhere nearby on S 85 St.

Clark stated the only way to get ahold of Matt Hoppe was through Facebook. Clark stated that Matt attempted to order a beer inside the bar and got upset when the bartender advised him that he would not serve him because of his intoxication level. Clark stated Matt got upset and began yelling. Clark stated he walked out of the bar with Matt as Matt removed a knife from his pocket and began to attempt to cut the tires of the truck parked on the street. Clark stated she observed Matt cut the tire and then take off running. Clark does not know where Matt lives and doesn't know how to contact him.

Based upon the statement provided by Clark I had no reason to hold her. Clark stated she was going to return home for the night. Bar staff advised they have seen the female inside of the bar multiple times prior with the same male. Clark denied knowing the male besides through Facebook.

INVESTIGATION

I was unable to come up with any information for an individual named "Matt Hoppe". A KGIS search also yielded no results for a male at approximately 25 years of age. However, when I searched for "Brad Hoppe", I located a male residing at 1511 S 82 St West Allis, WI. I decided to check the residence for the suspect. I arrived on scene with Officer Schweitzer.

As we walked up to the residence, I observed a male wearing a camouflage jacket covered in burrs sleeping on the front steps. The male had his cell phone in his hand but was evidently fast asleep. Officer Schweitzer advised he had observed the video footage, which showed the male wearing a camouflage jacket causing a problem within the bar and eventually using the knife to cut the tire.

Based upon this information I immediately detained the male due to the possible presence of a knife on his person. While within a close proximity of the male I immediately detected a strong odor of intoxicants emitting from his breath. I placed the male in the rear of my squad. The male, identified as Joseph W. Hoppe, briefly stated he was sleeping at his cousin's residence before being woke up by police.

I responded back to the bar where I spoke with staff. While standing on the sidewalk, I observed the female involved, Cayla Clark, drive by. Clark initially advised me that she did not know where the male resided and that she was going home. Officer Schweitzer initiated a traffic stop on the vehicle at S 81 St/W Orchard St where he took the female into custody. While I spoke with Clark she

advised that I forgot to return her driver's license back to her and she was trying to find me to get it back.

Based upon Clark's knowledge of the male suspect (Joseph Hoppe) and providing false information about his person, and her return to the area and attempting to travel to the residence of Brad Hoppe (1511 S 82 St), I arrested her for Obstructing an Officer.

IN CUSTODY STATEMENT OF OFFENDER - CAYLA CLARK

On 11/23/14 at 0420hrs in at the substation holding room A, I read Clark her Miranda Rights from WAPD Directive 42.016. In response to waiver questions, Clark stated she understood her rights and refused to speak with me at the time.

The interview concluded at 0420hrs. The interview was recorded using WAPD Olympus Digital Voice Recorder. I placed the memory card in an envelope and secured it in the ID Bureau drawer.

IN CUSTODY STATEMENT OF OFFENDER - JOSEPH HOPPE

On 11/23/14 at 0422hrs in at the substation holding room B, I read Hoppe his Miranda Rights from WAPD Directive 42.016. In response to waiver questions, Hoppe stated he understood his rights and refused to speak with me at the time.

Both parties were issue their citations and released from the substation. They were given a court date of 12/22/14 at 0830hrs.

NARRATIVE

CALL FOR SERVICE

On 11/23/14 at approximately 0303 hrs, I responded to 8812 W Greenfield Ave, Stallis Palace, for a report of a male slashing the tires on a vehicle outside of the bar.

VICTIM STATEMENT - MATTHEW JASKULSKI

Upon my arrival, I made contact with the victim, Matthew R Jaskulski, M/W, 04/04/83. Matthew is the doorman at Stallis Palace. Matthew stated, a male inside the bar, wearing a pink button down shirt, a white undershirt, a camouflage jacket, approximately 5'10" and 170 lbs, was intoxicated inside the bar and creating a disturbance. Before bar closing the bartender refused to

outside of the bar, he observed this male and a female, later identified as, Cayla N Clark, F/W, 06/16/92, walking eastbound on W Greenfield Ave. Matthew's vehicle, WI/REG Plate, AL5080 a 2011 Dodge Ram 1500, was parked on the north side of W Greenfield Ave, in the 8800 BLK. Matthew observed this male who was wearing the camouflage jacket, reach into his right pocket and pulled a shinny metal object, which Matthew believed to be a pocket knife. As this male walked by Matthew's vehicle, he observed the male stab his right rear tires at least three different times.

After stabbing the tire, Matthew observed this male continue and female continue walking eastbound on W Greenfield Ave. Matthew began following the male and female eastbound on W Greenfield Ave. Matthew then observed the male start running eastbound on W Greenfield Ave and then northbound on S 88 St. Because of this male running from the scene, Matthew stopped the female and brought her back into the bar to wait for officers to arrive. Matthew advised his vehicle is insured by American Family Insurance.

After speaking with Matthew, I was able to obtain a video of the male offender, slashing the tire on the vehicle. I also obtained photographs of the offender inside the bar. These photographs and video were later attached to the case.

LACK OF CONSENT

Matthew did not give Joseph Hoppe consent to damage his tire.

DAMAGE TO VEHICLE

A right rear Firestone Destination tire was damaged by Joseph Hoppe. The total damage to the tire is approximately \$200.00.

OBSERVATIONS OF FEMALE OFFENDER

After clearing Stallis Palace, I observed the female walk to a vehicle parked in the 1300 BLK S 89 St. This vehicle, WI/REG Plate, 488VNX, a 2014 Nissan Versa 4-Door. I followed this vehicle to the on-ramp for 894 Northbound. I

responded back to Stallis Palace after observing this female drive onto the freeway.

FOLLOW UP AT 1511 S 82 ST

Officer Foy and I responded to 1511 S 82 St to attempt contact with the male party regarding this incident. While walking to the front of the residence, I observed this same vehicle, the 2014 Nissan Versa, WI/REG Plate, 488VNX drive southbound on S 82 St. I observed the same female driver from the bar driving the vehicle. While walking to the front of the residence officers located the offender sleeping on the front walkway to the residence and he was taken into custody without incident.

TRAFFIC STOP

After taking the male into custody I responded back to Stallis Palace to advise the victim, Matthew Jaskulski the offender was taken into custody. While speaking with Matthew outside of the bar, I again observed this vehicle, the 2014 Nissan Versa, WI/REG Plate, 488VNX, with the same female driver, driving eastbound on W Greenfield Ave. While behind the vehicle, I ran the registration through WI-DOT. The registration came back as expired. I also observed the female driver was not wearing a seatbelt. I conducted a traffic stop at S 81 St/W Orchard Ave. I made contact with Cayla N Clark, F/W, 06/16/92. I asked the Cayla to step out of the vehicle and placed her under arrest for Obstructing an Officer. Cayla stated, officers forgot to give her ID back after leaving the bar and wanted it back.

BOOKING

I booked Cayla at the substation with WAPD Booking # 14-005505 for Obstructing an Officer. I issued Cayla Municipal Citation # M14005505-1 for Obstructing an Officer. I also issued Cayla Uniform Traffic Citation # U705105-2 for Vehicle Operator Fail/Wear Seat Belt and Uniform Traffic Citation # U705104-1 for Non-Registration of Auto.

After the booking process was complete. Cayla was released from the substation.
