Dear Mayor Bell:

I am writing as part of our efforts to keep you apprised of developments involving Time Warner Cable.

This is to advise you that depending on the progress of ongoing negotiations Time Warner Cable may be forced to discontinue carriage of the following channels in the near future: BET, BET On Jazz, MTV, MTV 2, MTVS (Español), MTV HITS, Nickelodeon, Nickelodeon Games & Sports, Nickelodeon Too, Nick Toons, Noggin, VH-1, VH1 Classic, VH1-Uno, and WITI (FOX). While we are hopeful that agreements will be reached to continue providing these channels to our customers, we are required to provide our customers and Local Franchising Authorities with adequate notification of any loss or possible loss of programming.
