The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of June 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case 09-004673, 05/29/09 at 2200hrs. St Aloysius Festival, 1405 S 92 St.

On the above date and time officers were walking through the festival grounds at St. Aloysius when they were informed of a large fight in progress. Three males were actively fighting with security. All were restrained and arrested for Disorderly Conduct. One of the males was also held on a Probation Hold from the State of Wisconsin. The fight started over one of the males bumping into the others cousin.

Case 09-004681, 05/30/09 at 0140hrs. Paulie's Pub, 8031 W Greenfield Ave.

On the above date and time officers were called to the parking lot at Paulie's Pub in regards to a fight. A male stated that he was walking home from the Derby when he was jumped by approx. 5 males in the parking lot at Paulie's. The male was intoxicated and stated he did nothing to provoke the incident. The incident was called in by a resident of the apartment building just to the east of the lot. No suspects. Bar owner was cooperative with officers.

Case 09-004682, 05/30/09 at 0155hrs. Paulie's Pub, 8031 W Greenfield Ave.

On the above date and time while officers were investigating a fight in the parking lot at Paulie's a staff member came outside and stated that there was a fight in progress in the tavern. The fight was between three male parties and started on the dance floor. The owner requested all three parties involved be cited. Three combatants were arrested for Disorderly Conduct.

Case 09-004910, 06/05/09 at 2344hrs. Junebugs, 6231 W Mitchell St.

On the above date and time officers responded to a call from the bartender of Junebugs in regards to an intoxicated male refusing to leave. The male was eventually removed by officers and arrested for Disorderly Conduct.

Case 09-005197, 06/13/09 at 0157hrs. Mario's, 1900 S 60 St.

On the above date and time while monitoring Mario's at bar closing officer observed a large fight involving four parties break out in the entryway to the tavern. All four parties involved in the fight were arrested. One of the parties involved turned out to be underage and the owner of the tavern was also cited for permitting underage person to enter/remain on licensed property.

Case 09-005362, 06/18/09 at 0200hrs. HD Hideout, 6201 W Mitchell St

On the above date and time officers responded to a call from the bar owner in regards to a male in the bar displaying a knife. The knife was 17" long. The male had been kicked out of the tavern because he was intoxicated. The male left for several minutes and then came back into the bar brandishing the knife. The party was arrested for disorderly conduct while armed.

Case 09-005426, 06/20/09 at 0107hrs. Spot Lite, 6426 W Greenfield Ave.

On the above date and time officer responded to a call for assistance from staff at the Spot Lite tavern due to problems with several patron's All parties were sent on way except for one who was arrested for Obstructing for providing officers with a false name.


Case 09-005457, 06/20/09 at 2323hrs. Buggy's Tavern, 6851 W Beloit Rd

One of the parties involved received 17 stitches to the head and stated that the owner of the tavern Scott Hintz was the party who struck him. This party did not want to be involved in any type of prosecution.
