The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of May.

Incident reports:

Case # 13-003831, 05/05/2013, at 0726 hrs – 9442 W. National Av, Brooklyn's.

On 05/05/2013 at 0726 hrs., Officers responded to 7605 W. Greenfield Av, for a male who was assaulted several hours ago outside of Brooklyn's. Officers met with the victim who stated he was intoxicated at Brooklyn's last night and went outside to have a cigarette at approximately 0130-0200 hrs. While outside, the victim was struck in the face by an unknown male, which caused the victim to fall to the ground and lose consciousness. The victim was assisted up by bouncers from Brooklyn's. He wanted to go back inside to continue drinking, but the bouncers would not allow him to. They only allowed him to go inside Brooklyn's to call a cab and he left a short time later in a cab. The victim went home, where he realized how much he was bleeding and then obtained another ride to AWAMS for medical attention. He did not initially report the incident because he did not think his injuries were too bad.

Officers attempted to obtain video footage from Brooklyn's, however, the owner, Dominic LaLicata, advised he would not be able to retrieve the surveillance footage because there is an unknown problem with the equipment. The employees were aware of the incident, but did not call the police.

Case # 13-004564, on 05/25/2013, at 0116 hrs – 1901 S. 60 St, Las Palmas

On 05/25/2013, at approximately 0116 hrs, Officers responded to 1901 S. 60 St, Las Palmas restaurant, for a report of a trouble call. Investigation revealed Julio Soto was highly intoxicated, and reportedly harassing patrons inside the above establishment. He was escorted out of the

establishment by Wisconsin Patrol Services security as a result, then created a disturbance outside the establishment, and began confronting one of the security officers in a threatening manner. Soto was detained by these security officers and taken into police custody. He was issued a municipal citation for Disorderly Conduct and released.

Case # 13-004566, on 05/25/2013, at 0205 hrs – 8423 W. Greenfield Av, O’Connors Perfect Pint

On 05/25/2013 at approximately 0205 hrs., Officers responded to Aurora West Allis Medical Center regarding a female caller who was bit by a dog at O’Connors Perfect Pint, 8423 W. Greenfield Av. Officers made contact with Brittany Barbian who stated she was bit in the face by a Rottweiler at the tavern. Barbian stated she was inside O’Connors Perfect Pint tavern when an unknown subject brought a Rottweiler inside. Numerous people went up to pet the dog, as well as Barbian. As she was standing over the top of the dog, it bit her in the face unprovoked. O’Connor, the owner was on scene for the incident, but did not call for the police to respond.
