

Ofc. Rapp reports:On 12/14/14 at 1923 officers responded to The Drunken Duck at 5906 W Burnham St. Hector Guillermo, M/W, 3/13/1953, reported that "Mike Awtry," M/W, 40-50 yo, bald, had assaulted him. During the Packer game, about 1300 or 1330 hours, Awtry came into the bar and pushed Guillermo, causing him to fall and strike his head. Guillermo refused medical attention. Awtry also told Guillermo he would beat him up if he saw him on the street. Guillermo did not wish to press charges, but wanted police to be aware. A records check could not locate a "Mike Awtry."
