**RESOLUTION TO AUTHORIZE A TRANSFER OF \$22,000 FROM THE
INFORMATION TECHNOLOGY SALARY AND WAGES ACCOUNT TO THE
INFORMATION TECHNOLOGY – PROFESSIONAL SERVICES ACCOUNT TO RE-
ARCHITECT OUR GEOGRAPHICAL INFORMATION SYSTEMS (GIS)
INFRASTRUCTURE WITH GISINC**

WHEREAS, for the past 18 months the GIS practice for the City has not been meeting the needs of our end users. GIS is used extensively by our DPW and Engineering departments to track and manage many of the physical assets in the City (buildings, trees, sewer lines, electrical grid, property addresses, etc...). Performance of the maps/apps has been slow, maintenance of the data has eroded, and we are not able to take advantage of some of the features that come with our ESRI software because we are behind in our upgrades; and,

WHEREAS, on September 25th 2020 the GIS Administrator resigned from the City presenting us the opportunity to look differently at how we want to deliver future GIS Services for the City; and,

WHEREAS, a contract was signed with GISinc to perform an assessment of our GIS practice. Their top recommendation is a complete rebuild of our GIS infrastructure to meet the future needs of the City; and

WHEREAS, we kept 50% of the salary and benefits for the former GIS Administrator in the 2020 General Account specifically in case we needed to have a vendor help us run our GIS program for the City; and

NOW THEREFORE, be it ordained by the Council of the City Of West Allis, in the State of Wisconsin, as follows:BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the contract dated July 29th, 2021 for consulting services from GISinc for the City of West Allis for the net sum not to exceed \$22,000 be and is hereby accepted. The account where this will be charged to is account # 100-1101-517.30-02 with money transferred from 100-1101-517.11.01.

BE IT FURTHER RESOLVED, that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid services.
