PART IV. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART V. This charter ordinance shall take effect sixty (60) days from and after its passage by a two-thirds (2/3) vote of the Common Council and publication, unless within such sixty (60) days a Referendum Petition shall be filed as provided by Sec. 66.01, Stats., in which event this ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting there-

The Common Council of the City of West Allis adopted the following charter ordi-nance which will become effective 60 days after publication. CHARTER ORDINANCE NO. 23 CHARTER ORDINANCE NO. 23 to repeal Charter Ordinance No. 23 to repeal Charter Ordinance No. 19 and provide a referendum on the issuance of General Obligation Bonds for specified municipal purposes

Charter Ordinance No. 19 is hereby repealed.

PART II. Except as provided in the last sentence of "Part III" hereof, pursuant to Sec. 66.01(4). Stats., the City of West Allis hereby elects not to be governed by those portions of Sec. 67.05(7), Stats., relating to submission to the electors of the City the question of the issuance of general obligation bonds for certain municipal purposes hereinafter enumerated.

PART III. Hereafter, no general obliga-tion bonds or promissory notes shall be issued by the City for street improve-ments, in 'a cumulative annual amount (within any one calendar year), in excess of three million seven hundred fifty thousand dollars (\$3,750,000.00), until the initial resolution or resolutions thousand collars (\$3,750,000.00), inthe initial resolution or resolutions therefor, following adoption by the Common Council, shall have been submitted the electors of the City and approved majority voting thereon.
