

**CITY OF WEST ALLIS
RESOLUTION R-2026-5441**

**RESOLUTION TO ACCEPT THE PROPOSAL OF FUREY FILTER AND PUMP,
INC. FOR THE REQUIRED REPAIRS TO THE EXISTING CASCADE PUMP #3 AT
THE STORM WATER PUMPING STATION LOCATED AT 2179 S. 111TH ST. FOR
\$25,000**

WHEREAS, the Cascade pump located at the Storm Water Pumping Station requires repairs due to age of the pump; and

WHEREAS, a repair estimate was requested from two Cascade pump service companies: Furey Filter and Pump, Inc. and LS Electric; and

WHEREAS, one estimate was received from Furey Filter and Pump, Inc. in the amount of \$25,000, with no response from LS Electric; and

WHEREAS, Furey Filter and Pump, Inc. was selected as only vendor to respond to the City's request for an estimate and given the previous work experience with the City for past rebuilds of Cascade pumps; and

WHEREAS, the Common Council of the City of West Allis deems it to be in the best interests of the City that the proposed estimate of \$25,000 from Furey Filter and Pump, Inc. be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated June 23, 2026, submitted by Furey Filter and Pump, Inc. for the sum of \$25,000 be accepted.

BE IT FURTHER RESOLVED that funding for this project will be charged to Storm Water Capital Account: 540-1801-538-4408.

BE IT FURTHER RESOLVED that the Finance Department is authorized to issue a purchase order for the aforesaid.

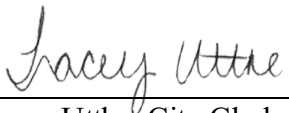

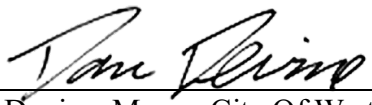
