The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of May 2009

Police report incidents involving licensed businesses:

Tavern reports:

**Case # 09-003782, 05/03/09 at 0127hrs, 1454 S 92 St., Wild Bill's Saloon**

On the above date and time officers were called to Wild Bill's Saloon in regards to a disorderly male waving around a handgun inside the tavern. The male left the bar before officers arrived and was arrested walking down the street. **The bartender Tammy M Wetzel was very uncooperative with officers stating she did not see the gun or the incident. Wetzel stated she also did not call the police.** Witnesses contradicted her statement and also claimed she picked up the gun and threw it in the trash. The male was charged at the Milwaukee County D.A.'s Office with Felon in Possession of a Firearm. See statement of Wetzel on page 9 of the incident report.

**Case# 09-004077, 05/12/09 at 0139hrs, 1101 S 60 St, Shawna's Pub and Grill**

On the above date and time officers **were called by the owner of Shawna's Pub and Grill Christopher Wheat** in regards to a female in the tavern who struck another patron and who may possibly have a weapon. The woman was seen by officers leaving the tavern in her vehicle at a high rate of speed and pulled over. She was arrested for battery and Operating While Intoxicated.

**Case# 09-004193, 05/16/09 at 0229hrs, 8911 W National Ave, Magoo's**

On the above date and time officers responded to a fight between two males inside of Magoo's in which one of the parties was knocked unconscious. Officers learned that this was a one punch altercation and that the offender had fled the scene with his girlfriend in her vehicle. Vehicle was stopped a short distance from the scene and party was arrested for Battery. Unsure if anyone from the tavern called as statements from several of the bouncers indicate that the offender was kicked out of the bar after the incident.

**Case# 09-004224, 05/17/09 at 0135hrs, 7930 W National Ave, The Jock Stop**

On the above date and time officers responded to the Jock Stop in regards to an anonymous complaint of an underage woman in the bar. A twenty year old female was identified and admitted to drinking in the bar as well as patronizing the bar 3 to 4 times a week for the past 6 months. The woman and bartender were both cited.

**Case# 09-004409, 05/21/09 at 2155hrs, 1101 S 60 St, Shawna's Pub and Grill**

On the above date and time officers were called to assist with a fight involving 4 males. One of the males was struck in the side of the face with a pint beer mug. Three of the parties involved were arrested for disorderly conduct and the fourth party fled the scene and has yet to be identified. Injured party required thirty stitches to close his injuries. **Tavern owner cooperative and was one of the callers.**

**Case# 09-004447, 05/22/09 at 2222hrs, 1325 S 70 St, Boz's Sports Bar and Grill**

On the above date and time officers responded to a report of an incident inside of Boz's where a woman struck another woman in the face causing a laceration over her eye which required 4 stitches. The apparent argument was over a male that the victim is dating who used to date the offending female. Offender was arrested for Substantial Battery. **The owner assisted in providing a tape of the incident.**

**Case# 09-004682, 05/30/09 at 0155hrs, 8031 W Greenfield Ave. Paulie's Pub**

On the above date and time officers responded to Paulie's for a report of a disturbance in the parking lot. **While in the lot an employee of Paulie's approached officers to inform them that there was a fight in progress inside the bar.** Three males were eventually arrested and issued local citations for disorderly conduct.

**Tobacco and Alcohol Compliance checks;**

**Case 09-004390, 05/21/09 at 1254hrs.**

On the above date and time an officer from the West Allis PD conducted 9 random tobacco compliance checks with the assistance of a 17 year old civilian. Of the 9 checks 2 merchants failed to comply and sold to the underage party. The businesses that failed to comply were Maas 5930 W Greenfield Ave. and BP Gas located at 5926 W Beloit Rd.
