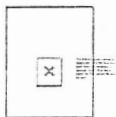

SUMMARY

Officer Lentz reports... On 10/21/12 at 0238 hrs., officers responded to an assault at S. 96 St. and W. Cleveland Ave. Andrew S. Stelloh, M/W 11/18/85, instigated a physical fight by striking John J. Nipper, M/W 10/15/79, causing him to fall to the ground and bleed from above his right eye. Stelloh was held back by two bystanders, as Nipper's brother, Nicholas N. Pucci, M/W 09/26/89, came to check on his brother. Pucci felt threatened by Stelloh, and believed Stelloh was going to hit him so he punched him, causing his nose to break. Pucci was arrested for Substantial Battery, with an order in date for Intake Court of 10/24/12 at 1330 hrs. Stelloh was transported to Froedtert Hospital where a hold was placed as he is arrested for Battery with an order in date for Intake Court on 10/25/12 at 1330 hrs for causing injury to Nipper. An apprehension request was generated for Stelloh.

Officer Lentz reports...

INITIAL CALL

On 10/21/12 at 0238 hrs., officers responded to an assault at S. 96 St. and W. Cleveland Ave.

Upon arrival I observed a white male, later identified as Andrew S. Stelloh, sitting on the on the northeast corner of S. 96 St. and W. Cleveland Ave. bleeding from his face. There were two individuals, later identified as Jeffrey S. Wolf and David J. Messervey, with Stelloh attempting to keep him calm. Stelloh appeared to be highly intoxicated.

Officers also made contact with a white male on the south west corner of S. 96 St. and W. Cleveland Ave. The individual, later identified as John J. Nipper, had cut above his right eye and blood on his hands and shirt. Nipper appeared to be highly intoxicated.

CONTACT WITH JOHN J. NIPPER

Officers made contact with John J. Nipper, M/W 10/15/79, on the southwest side of S. 96 St. from W. Cleveland Ave. Nipper was bleeding from above his right eye, and had blood on his arms and shirt.

Nipper was detained by officers as an investigation of the incident took place. Nipper was not very cooperative, and was unable to explain why he had blood on himself and his clothing.

Officers asked Nipper if he needed to be seen by a medical unit, he stated he would be alright.

When asked if he struck Stelloh, Nipper stated he did not remember what happened and he hoped the other guy (Stelloh) was alright. When asked if he knew Stelloh, Nipper stated he had just met him.

Officers learned of Nipper's brother as being possibly involved in the incident. Nipper stated his brother was not out with him, and was not involved.

Nipper was given a courtesy ride to his residence at 9734 W. Cleveland Ave.

STATEMENT OF JEFFREY S. WOLF - WITNESS

Wolf observed Stelloh hit Nipper while on the northeast corner of S. 96 St. and W. Cleveland Ave. Wolf stated a second individual, a white male wearing a dark t-shirt, and dark jeans, approximately 5'07", 185 lbs., with dark hair, came towards Stelloh.

The individual, later identified as Nicholas N. Pucci, M/W 09/26/89, said to Stelloh, "what are you doing to my brother?" Pucci then punched Stelloh in the face, causing injuries to his nose.

Wolf stated he stayed with Stelloh to calm him down until medical help came for him.

STATEMENT OF DAVID J. MESSERVEY - CALLER

David J. Messervey, M/W 08/25/65, stated he heard a disturbance outside on W. Cleveland Ave. Messervey went outside and observed Stelloh outside, bleeding from his face. Wolf told Messervey to call for help, at which time he called the police.

Messerverey along with Wolf stayed with Stelloh until police and rescue arrived on scene.

CONTACT WITH NICHOLAS N. PUCCI - OFFENDER

Officers made contact with Nicholas N. Pucci at 3735 S. 89 St. Pucci stated he was at the Network Tavern, 9541 W. Cleveland Ave., West Allis, when he heard his brother, John J. Nipper, arguing with Andrew S. Stelloh inside the tavern. Pucci stated the two were arguing over whether or not a bottle of alcohol was a "fifth."

Pucci observed Nipper and Stelloh go outside to a vehicle, and return with a bottle of Jack Daniels. While inside the Network, a bartender took the bottle of alcohol away from the two.

Nipper and Stelloh then left the tavern and crossed W. Cleveland Ave. Pucci observed Stelloh punch Nipper, causing him to fall to the ground. Pucci went to aid Nipper while Stelloh was being helped by two other bystanders. Pucci yelled to Stelloh, "What are you doing?"

Stelloh was attempting to go through the two people helping him. Pucci believed Stelloh was going to hit him or Nipper, so he defended himself by throwing a punch towards Stelloh.

Pucci was advised he would be brought to the station and would be have an opportunity for a recorded statement. Pucci was sober, and very cooperative.

Pucci was mugged and printed using WAPD booking # 2012005382 for Substantial Battery.

NARRATIVE

Officer Said reports...

INITIAL OBSERVATIONS

On 10/21/12 at approximately 0239 hrs, Squad 399, Officer Said responded to the area of S 96 St / W Cleveland Ave for report of a an assault and a male on scene bleeding from the face. Upon arrival I observed Officers Lentz and Pinter were speaking to individuals on scene. I made contact with a male seated on the northeast corner of the intersection bleeding from the nose and mouth who was later identified as Andrew S. Stelloh.

ON SCENE CONTACT - ANDREW S. STELLOH

I immediately observed blood and swelling on the nose and upper lip of Andrew S. Stelloh and I observed that Stelloh's nose looked to be abnormally pointed to the right side of his face. There was a large amount of blood on the street near Stelloh and blood on Stelloh's clothing. Stelloh had the distinct odor of intoxicants on his breath, Stelloh's speech was slurred and slow and Stelloh lacked balance, unable to walk or stand without assistance. During my contact with Stelloh his behavior was erratic, he was at moment very sad and crying then very angry and slapping his fist against the palm of his other hand while yelling.

The following is a synopsis of the statements made by Andrew S. Stelloh during my contact with him:

Stelloh stated he went to The Network Bar, 9541 West Cleveland Ave, at or around 1900 hrs. Stelloh stated he did not remember the names of anyone inside the bar, but he was sure his friend Erin Payne was there during his stay at the bar.

Stelloh said he was struck in the face by the closed, right fist of someone. Stelloh was not sure why this occurred. Stelloh does not recall any arguments prior to being struck in the face.

I asked Stelloh if he recalled a bottle of whiskey being brought inside the bar. Stelloh stated he left the bottle inside the car. Stelloh said he did not know what happened and he did not remember anything from earlier in the evening. Stelloh repeated numerous times he did not deserve this.

INITIAL CALL

Officer Pinter reports...

On 10/21/12 at 0239 hrs, Officers were dispatched to the 9600 blk. / W Cleveland Ave. for a report of an assault. Upon arrival, I located a male party (later identified as Andrew S Stelloh M/W, 11/18/85) on the southwest corner of W Cleveland Ave. / S 96 St. (sidewalk). Andrew was bleeding from his nose. It appeared that his nose was broken.

I also observed a male party (later identified as John J Nipper M/W, 10/15/79) standing across the street. John was speaking with someone in a red vehicle. This female was later identified as Michele L Minder F/W, 05/06/77. John was bleeding from his forehead. Due to the severity of Andrew's injury, I advised John that he was temporarily being detained. I placed him in handcuffs. Officer Lentz placed John into his squad car and I spoke with Michele about the incident.

STATEMENT - MICHELE MINDER

Michele explained she was at the Network tavern when the incident happened. Michele said at closing time, Andrew came into the tavern with a bottle of Jack Daniels. She said the bartender (later identified as John F Feuerstein M/W, 01/18/68) took the bottle away from Andrew and escorted him out of the tavern. Andrew became upset and started yelling and causing a disturbance.

Michele said it took a few people to escort Andrew outside. Michele said she went outside and observed Andrew yelling at John Nipper. Michele observed Andrew punch Nipper in the face. She said Nipper fell to the ground and Andrew walked away. She walked over by Nipper and she believed that he was "knocked out cold".

Michele said while she was attending to Nipper, she observed someone attempting to stop Andrew. She continued to ask Nipper if he was ok and he did not respond. A short time later, Nipper came to and said he was ok. She looked across the street and observed Andrew lying on the ground. She did not know how Andrew fell to the ground. Michele stated Andrew was the problem and punched Nipper. She said Nipper did not do anything wrong.

STATEMENT - JOHN FEUERSTEIN

I walked inside of the tavern and spoke with the bartender. She was later identified as Carmen L Hazelberg F/W, 08/18/77. Carmen did not witness the incident. She said an employee was at the tavern and he witnessed the incident. She provided me with his name. He was identified as John F Feuerstein. She said he left the tavern. Carmen was able to contact Feuerstein, via cell phone.

I spoke with Feuerstein about the incident. He said he was at the tavern this evening, but he was not bartending. Feuerstein said he was seated at the bar, when Andrew attempted to come into the tavern with a bottle of Jack Daniels. Feuerstein said he took the bottle away from Andrew and asked him to leave. At that point, Andrew became upset and started swearing and causing a disturbance.

Feuerstein said he escorted Andrew outside and he went back into the tavern. He dumped the bottle out and he went back outside. As he got outside, he observed Andrew punch John Nipper in the face. He said Nipper fell to the ground and Andrew walked across the street. I asked him how Andrew was injured. He said he did not know. He said there were three people trying to calm Andrew down. He said Andrew was yelling and swearing while he was outside. Feuerstein also said Andrew caused the problem. I again asked him how

Andrew was injured. He said he did not witness anything across the street.

CONTACT AT 9734 W CLEVELAND AVE - CONTACT WITH OFFENDER NICHOLAS PUCCI

It was later revealed that John Nipper's brother, later identified as Nicholas N Pucci M/W, 09/26/89 possibly punched Andrew in the face. I responded to 9734 W Cleleland Ave. I made contact with Nicholas mother. She was identified as Regina R Luistrow F/W, 03/30/60.

Luistrow said Nicholas was not at the residence. She called Nicholas and I spoke with him. He said he was at his girlfriend's residence 3735 S 89 St. I told him I needed to speak with him about the incident. Nicholas was very cooperative when I spoke with him. He said he would be waiting outside. I responded to the residence.

ARREST OF NICHOLAS PUCCI

Based on Nicholas stating he punched Andrew in the face, I advised him the he was under arrest for Substantial Battery.

MIRANDIZED STATEMENT

At 0405 hrs, I began talking with Nicholas in interview room A of the Booking Area. I advised him of his constitutional rights by reading from the WAPD policy on Audio Recording of Suspect Interviews - Adults. Nicholas stated that he understood his rights and he agreed to make a statement without a lawyer present. The following statement was paraphrased.

I asked Nicholas about the incident. He said he was at the Network tavern with his brother, John. Nicholas said he has never met Andrew. He said Andrew arrived at the tavern at approximately 11 p.m. Nicholas said just before closing time, John and Andrew were involved in an argument over liquor. He said Andrew and John went outside. John came back inside and Andrew came into the tavern a short time later. He said Andrew had a bottle of Jack Daniels.

Nicholas said the bartender took the bottle away from Andrew and Andrew became upset. He said Andrew was swearing and causing a disturbance. Nicholas said the bartender pushed Andrew outside. Nicholas said John and other male patrons went outside to calm Andrew down. Nicholas said while he was still inside of the tavern, he could hear Andrew yelling.

Nicholas walked outside and observed Andrew punch John in the face. He said John fell to the ground and Andrew started walking away. Nicholas said he went to stop Andrew and ask him why he hit his brother. Nicholas said he grabbed Andrew by the shirt in an attempt to stop him. Andrew started flailing his
