RE: PDD (Plan District Development) rezoning overlay for WI Self Storage

Dear Mr. Schaer,

It was a pleasure talking to you today about 2 other options regarding my currant application to rezone my vacant 2.5 acre lot from C-4 to M-1 in order to allow for outdoor self storage and U-Haul truck and trailer rental at my WI Self Storage property located at 11100 West Cleveland Avenue.

Based on our phone conversation and one I had with the City Attorney, Scott Post earlier today, I would like to ask the Common Council and the Safety and Development Board to consider the option to not rezone my property from C-4 to M-1 but to consider adding a PDD zoning overlay on top of the existing C-4 zoning for the purpose of keeping the property out of M-1 zoning but allowing me the use of the property for outdoor self storage as my development proposal shows and U-Haul truck and trailer rental services. I have attached your city zoning map that shows several examples of PDD zoning overlay areas on top of C-4 and C-3 zoning.

We also discussed the idea of amending the C-4 zoning to allow self Storage and truck and trailer rental as a special use under C-4. If the City does consider this option, it would solve the issue that some existing retailers such as Home Depot, Menards and Valvoline Car Care, would be able to continue renting trucks and trailers at their properties, as they already do, under the C-4 zoning.

Attached is a petition signed by 25 residents that I started this past weekend asking the neighbors if they would be in favor of allowing me to develop my vacant lot as outside self storage. I plan on continuing to meet with the rest of the residents over the next week and I will present a final copy of the petition at the July 7th, Common Council and Safety and Development Board.





