**RESOLUTION NAMING STREET TO BE CONSTRUCTED BETWEEN S. 60TH ST.  
AND THE EASTERN TERMINUS OF W. WASHINGTON ST. (APPROX. 1450 FT. EAST  
OF EAST RIGHT-OF-WAY LINE OF S. 70TH ST.) WEST ALLIS-CHALMERS DRIVE**

**WHEREAS**, The West Allis Common Council has determined that a new street is needed to connect W. Washington St. east to S. 60th St. as mitigation for the removal of the S. Hawley Rd. Ramps as part of the WisDOT I-94 East West Corridor Project; and,

**WHEREAS**, the City has an agreement with the WisDOT for said street to be constructed during the WisDOT E/W I-94 Corridor Project; and,

**WHEREAS**, the City must choose a name for the new road; and,

**NOW THEREFORE**, BE IT REOLVED by the Common Council of the City of West Allis chooses the name of the new street from W. Washington St. east to S. 60th St. to be West Allis-Chalmers Drive.


