Officer Wink reports.....

PARAMATERS OF THE ALCOHOL COMPLIANCE CHECK

On today's date I conducted an alcohol compliance check using a 20 year old female, Brittni Kompas. Brittni had just recently turned 20 years old in August 2009. I instructed Brittni to enter each randomly selected business and attempt to purchase an alcoholic beverage. I provided Brittni with \$20.00 buy money and also if she was asked her true age she was to tell the clerks she was 20 years of age. Brittni was not allowed to have any identification on her person at the time of the compliance check. Approximately 5 minutes before going out on the compliance check, I took a digital photo of Brittni with media card #IDB10.

DHILLON BEER AND LIQUOR 5832 W. BURNHAM ST.-OFFENDING BUSINESS

At 1103 hrs. I had Brittni enter Dhillon Beer and Liquor at 5832 W. Burnham St. in attempts to purchase alcohol. Upon being in the store for a few minutes Brittni exited the store with a six pack of Mike's Hard Lemonade. I had Brittni leave the alcohol in the squad and walk back into the store with me. I had Brittni positively identify the male clerk who sold her the alcohol. Brittni pointed out the only clerk in the store who was identified by Wisconsin ID card as, Gurnaib Singh Sran. I gave Brittni the car keys and had her go back to the squad to wait for me while I wrote out the citation to Gurnaib.

Gurnaib was instructed he needed to card everyone that comes into the store that doesn't appear to be 21. There was a bit of a language barrier between Gurnaib and I, but he was cooperative and I explained the citation as much as I could to him. Gurnaib signed the PR Bond and was released on scene.

WEST ALLIS LIQUOR AND TOBACCO 7218 W. GREENFIELD AVE-OFFENDING BUSINESS

At 1122 hrs. I had Brittni enter West Allis Liquor and Tobacco located at 7218 W. Greenfield Ave. Brittni was in the store for a short time period and came out with a four pack of Seagram's wine coolers. I again had Brittni leave the alcohol in the squad and she walked into the store with me to identify the clerk. Upon walking in Brittni identified the only male clerk in the store as the one who sold the wine cooler's to her. I sent Brittni back to the squad to wait for me, while I issued citation #M-95022 to the clerk who was was identified by an international ID card as Amrinder Singh.

Amrinder told me he was confused. I asked Amrinder what could he be confused about. Amrinder was attempting to tell me his father was in the hospital and he just had a lot on his mind. I told Amrinder that I still needed to issue him a citation. Amrinder signed the PR bond and was released at the scene.

PROPERTY

Once I was completed with the compliance check I took Brittni back to the station and dropped her off. I then placed the Mike's Hard Lemonade on property sheet #52973 and the Seagram's wine coolers on property sheet #52974 to be destroyed.

I also placed the media card with Brittni's photo and face sheet in a sealed envelope and placed it in secure storage in the Forensic and Technical Service Bureau.
