You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

## **COMPLAINT**

Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Jeffrey Farrington as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected

  Alderperson for the First Aldermanic District in the City of West Allis, is the chair of
  the License and Health Committee, and makes this complaint at the direction of the
  License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, the West Allis Police Department, and the West Allis City Clerk's office, which records complainant believes to be reliable and accurate.
- 3. That Jeffrey Farrington is the holder of a operator's license, License No.09-580, to sell/serve alcoholic beverages under Chapter 125, Wis. Stat., issued by the West Allis Common Council for the license period beginning July 1, 2007, and ending June 30, 2009.
- 4. That Farrington was convicted of operating while intoxicated in 1995 and 2005.
- 5. That on October 30, 2008, Greendale Police Department Officer Jeffrey Dibb observed Farrington operating a vehicle on South 76<sup>th</sup> Street at approximately 2:40

- a.m. Farrington was speeding and deviating from his designated traffic lane.
- 6. That Officer Dibb stopped Farrington's vehicle and observed that Farrington had glassy eyes, slurred speech, and a strong odor of intoxicants emanating from his breath. Farrington stated that he had a few beers.
- 7. That based upon his observations, Dibb had Farrington perform three standard field sobriety tests. Farrington failed all of these tests, and Dibb arrested him for operating while intoxicated.
- 8. That approximately 50 minutes after driving, a nurse from St. Luke's Hospital drew Farrington's blood. The blood results indicated that Farrington's blood alcohol level was .19.
- 9. That Farrington was charged with operating while intoxicated 3<sup>rd</sup> offense, in violation of Wis Stat. § 346.63(1)(a), and pled guilty to that same offense on April 1, 2009.
- 10. That the conduct of Farrington substantially relates to the alcohol beverage licensed activity contrary to Wis. Stat. §125.04(5)(b) and West Allis Revised Municipal Ordinance 9.02 (12)(d), and are grounds for non-renewal, suspension, or revocation of his operator's license.

WHEREFORE, Michael J. Czaplewski, requests that Jeffrey Farrington be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Operator's License, License No. 09-580, of Jeffrey Farrington should be revoked, suspended, or not renewed.
