
Incident/Arrest Summary

2 M. 65 St., Milw 53213 Officer Wroblewski reports:

On Friday 01/17/03 at about 8:00 pm reporting officer assisted Officer Johnson in doing a walk through/ bar check of the Metropolis Club 6330 W Greenfield Ave. In checking the men's restroom of the club reporting officer noticed graffiti on the stall, stall door and a green shelf above the sinks. I did not recall the graffiti from assisting in previous checks. Some of the graffiti that stood out appeared to be MP13, a backwards C next to 41K. Reporting officer observed these statements in more then one location in the men's room.

I later spoke with the owner Ian Pesch, in regards to the graffiti. I asked if he would mind us taking a picture to informational purposes and to try and track if a problem was developing. Pesch stated that he could tell me what the graffiti meant. He identified the MP13 as "13 th Street Mexican Posse, a broken 5 point star as King Killer, and SMILIE" as a tag written by a kid that he had already kicked out of the club. He stated that the he was informed who wrote the Mexican Posse graffiti on the stall and had called the police on the group as they left that day. He stated that Officers had stopped the group driving away in a van and made some arrests from the vehicle. Pesch stated that the graffiti had been in the men's room for several months that they had just not thought of painting over it. He stated that other kids in the club often pointed out troublemakers and persons doing damage to him to prevent problems.

Reporting officer again asked if it would be OK to take a picture of the graffiti for informational purposes and to try and track the graffiti to see if a problem was developing. Owner stated that he would prefer that we didn't. I advised that I did not intend to file a report on this graffiti that I just wished to have some one view it to see if there might be a problem developing at the club. I advised that painting over the graffiti

and monitoring new graffiti would also be a good way for him to monitor the situation to prevent problems. He stated that he under stood our concerns but did not want the graffiti to make the club look bad and wasn't sure that city officials wouldn't view the graffiti in a negative way. He stated that he would get some spray paint right now and cover up the graffiti. I advised that that would be OK but I still wished to take a photo of the graffiti. Reporting officer requested a Polaroid camera and Sgt Waarvik responded. Officers were able to take 1 picture of the inside of the stall and one picture of the inside of the stall door. Pesch returned to the men's room with a can of spray paint and began to paint over graffiti in the stall. The camera ran out of film so Sgt Waarvik went out to the patrol van to get some more film. Pesch went over to the green shelf below the mirrors, to paint over that graffiti. I advised him that the Sgt went outside to get some more film, but Pesch painted over the backward C next to 41 K written on the shelf before Sgt Waarvik returned with more film to photograph it.

In checking with one of the doormen, who viewed the two photos of the graffiti, he advised that the graffiti appeared to be recent. He and another female employee also advised of additional graffiti along the rear and side of the building that was recent in nature. While enroute to check for additional graffiti officers came across a liquor laws violation in a vehicle by the front door of Metropolis. A patron identified by PO Johnson as a Chelsea J. Jorgensen, was exiting Metropolis and getting into a vehicle with alcohol visible in the possession of underage persons. The vehicle had pulled up to Metropolis and employees stated that it was loitering outside the front door waiting for Jorgensen.

A Gina Hernandez was arrested for a liquor laws violation in a vehicle infront of Metropolis, 6330 W Greenfield Ave as officers exited the club after performing the club check.
