Ladies and Gentlemen:

The Harley Davidson Motor Company will be celebrating its 100th anniversary this August by holding special events in the Milwaukee area. The majority of these events are being held at locations out side of the City of West Allis, with minimal impact on West Allis resources. The House of Harley Davidson, a dealership in Greenfield Wisconsin, along with the Milwaukee area Harley Owners Group (HOG) has leased the State Fair Park for the week prior to and the celebration weekend.

Part of the 'House of Harley ' scheduled events, include 4 theme parades which begin on Layton Ave. in Greenfield and will conclude at Wisconsin State Fair park. The House of Harley has properly filed applications for these events, paid the required fees and all 4 would be approved by the Police Department. City ordinance however, states that only one event should be held per month, without approval of the Common Council.

The Police Department, Mayor Bell, the Chamber of commerce, and downtown businesses would like to make the Harley events in West Allis as successful as possible. Baring any objection form the Council, all four permits will be approved and issued. The four theme parades will be in August on Saturday the 23rd, Sunday the 24th, Monday the 25th, and Thursday the 28th. These events will be leading up to the major H-D events held at Milwaukee's lakefront on Labor Day weekend.
