NARRATIVE

COMPLIANCE CHECK OUTLINE

On 09/24/14 from approximately 1545hrs to 1830hrs, I conducted a tobacco compliance check at 13 randomly selected West Allis businesses that have a license to sell tobacco. The check was completed through the use of a 17 year old female, Kayla J. Ehrhardt, F/W 06/04/97. Ehrhardt entered each of the randomly selected businesses and attempted to purchase a pack of Newport cigarettes without

providing any identification. I advised Ehrhardt if the sales clerk asked her for identification, she should not question the employee and immediately leave the business.

I provided Ehrhardt with \$40 from the WAPD Community Services Bureau fund for the attempted purchases.

Prior to beginning the compliance check I confirmed Ehrhardt did not have any identification on her person. The only item Ehrhardt brought with her during the compliance check was her cell phone. I took a photograph of Ehrhardt with a department issued digital camera, and I secured the photograph onto a WAPD media card to document Ehrhardt's appearance on the day of the compliance check. The media card was later secured in the Forensics and Technical Bureau.

COMPLIANCE CHECK DISPOSITION

On 09/24/14 I conducted a tobacco compliance check at 13 randomly selected West Allis businesses that sell tobacco. All but two of the businesses requested identification from the underage female who assisted with the compliance check. Employees from the two gas stations where identification was not required were issued municipal citations for Selling Tobacco Products to Minors. Municipal citations were also issued and mailed to the owners of both gas stations. The local court date is set for 10/27/14 at 0830hrs.

Out of the above 13 randomly selected businesses, 11 requested identification from Ehrhardt before they would complete the tobacco sale. An employee, Sharjeel Tariq, M/W 08/28/90, from the Mobil gas station, 2315 S. 76 St., and an employee, Tokeer Anjum Bajwa, M/W 08/23/66, from American Petro gas station, 5926 W. Beloit Rd., completed the sale of a pack of Newport cigarettes without requiring identification from Ehrhardt.

CONTACT AT 2315 S. 76 St.

After Ehrhardt exited the Mobil gas station with a pack of purchased Newport cigarettes, which cost \$7.80, I entered the business and made contact with the employee, Tariq. I advised Tariq he just sold a pack of cigarettes to a 17 year old female. Tariq admitted he sold the pack of cigarettes, but he stated Ehrhardt told him her identification was inside her vehicle. Tariq said Ehrhardt was supposed to go out to her vehicle after the sale was completed and come back with her identification so he could verify her age.

I issued Tariq a municipal citation, M-102561, for Selling Tobacco Products to Minors. Tariq was provided with a copy of the citation on scene, and his local court date is set for 10/27/14 at 0830 hrs.

A municipal citation, M-102563, for Selling Tobacco Products to Minors was also issued and mailed to the owner of the Mobil gas station, Sajid NMI Bashir, M/W 08/08/59. Bashir was also provided with a local court date of 10/27/14 at 0830hrs.

The next business, after the Mobil gas station, Ehrhardt attempted to purchase a pack of Newport cigarettes at was American Petro gas station. Ehrhardt entered the business and exited with another pack of purchased Newport cigarettes, which cost \$7.79. I entered the business and made contact with the employee, Bajwa. I advised Bajwa he just sold a pack of cigarettes to a 17 year old female. Bajwa stated Ehrhardt provided him with identification before he completed the sale. I told Bajwa she did not because she did not have any identification on her person when she entered the business. Bajwa advised this was the first time anything like this happened to him, and he recently took over the business. Bajwa also questioned me and asked how I knew she was not at least 18 years old if she did not have any identification.
