The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of February 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case 09-000901, 01/31/09 at 0147hrs. Mario's, 1900 S 60 St.

On the above date and time officers were called to Mario's in regards to a fight in the tavern that turned out to be a Domestic Violence call. A female got into an argument with the father of her child on the dance floor and he grabbed her by the throat and pinned her against a wall choking her. Patrons and security from the tavern eventually pulled the male off of the female. The male party was arrested for Domestic Violence Battery. The complainant was the owner Mario Morgese.

Case 09-001338, 02/14/09 at 0038hrs. Painted Parrot, 8028 W National Ave.

On 02/14/09 Officers were called to Froedtert Hospital to follow up on a report of a battery. The victim a female stated that at approx. 0230hrs she was punched in the face while in the parking lot at the Painted Parrot. On 02/25/09 the officer involved stopped at the Painted Parrot to follow up with possible bartenders on duty the night of the incident. The on duty bartender gave him several names and stated several of them would be working on 02/26/09. Officer returned that date and was confronted by the owner Gregory Barczak who was very uncooperative with the officer and refused to allow him to talk to any of his staff. As the officer left Barczak followed him outside and confronted him demanding his squad number and accusing the officer of swearing at him. The officer reported the complaint to his Commanding Officer.

Case 09-001359, 02/15/09 at 0003hrs. Walk Her Inn, 7329 W Walker St.

On the above date and time officers responded to several calls of parties fighting inside of and next to Walk Her Inn. Investigation revealed that an intoxicated female patron fought with two other female parties in the tavern and also fought with her live in boyfriend. The fight started over the boyfriend refusing to take the offender down into Milwaukee to buy some crack cocaine.

Case 09-001503, 02/19/09 at 0038hrs. Lynch's Tavern, 2300 S 108 St.

On the above date and time officers responded to Lynch's Tavern in regards to a battery complaint. Officers arrived to find an employee of the bar holding a male down who had punched another patron for no apparent reason. The offender was arrested for Battery and was very intoxicated. The bartender who called stated that she had cut the party off over 2.5 hours ago.

Call 09-007225, 02/21/09 at 0152hrs. Burnham Bowl, 6016 W Burnham St.

On the above date and time officers responded to a large fight call in the bar area at Burnham Bowl. Main combatants had left before officers arrived. Employees asked that all patrons left in the bar be escorted out. No charges issued.

Case 09-000468 & 09-001422 Arrests of Steven T Robinson, Top Gun, 1100 S 60 St.

On January 16th, 2009 and again on February 17th, 2009 Steven Robinson was stopped and arrested for DWI and also for Possession of Cocaine. See attached reports.

Tobacco and Alcohol Compliance checks;

On February 15th West Allis PD did tobacco compliance checks at 24 businesses throughout the city. All but 1 store was in compliance. The offending store was the Speedway located at 5712 W Burnham St. The clerk was cited along with a citation sent to Speedway SuperAmerica LLC.
