The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of June 2010. There is also one report from May that arrived too late for last month's report.

Police report incidents involving licensed businesses:

Incident reports:

Call 10-024129, 05/30/10 at 0134hrs. Mario's, 1900 S 60 St

On the above date and time bar owner Mario Morgese called to report that two males were fighting in the tavern. Officers arrived to find that the two parties involved had already fled the scene. Morgese then shut the bar down for the night.

Call 10-025389, 06/06/10 at 0035hrs. Larry Michael's, 8900 W Greenfield Ave

On the above date and time bar officers were called to a large fight in the bar at Larry Michael's. Two parties were identified as combatants in the fight. Parties were warned and sent on way.

On the above date and time officers were sent to Bunkers in regards to a noise complaint. Officers arrived and observed that the exterior speakers for the front and rear patio were still on. The bartender was contacted and apologized stating she forgot to turn them off. Warning issued. The complainant was notified and stated this was a problem all year and wished them to be cited if there was another complaint.

On the above date and time officers were called to a noise complaint at the Jock Stop. When officers arrived they noticed it was quiet at the Jock Stop and that the noise was coming from the Painted Parrot. The bouncer was informed of the complaint and closed the doors.

The other male involved denied buying or attempting to buy drugs and had nothing on his person at the time. This party was sent on his way and told that the owner no longer wished him to patronize the bar.
