WHEREAS, The Purchasing/Central Services Division has reported that it has received a proposal for cable franchise renewal consulting services for the City's Office of Cable Communication; and,

WHEREAS, The Common Council deems it to be in the best interests of the City of West Allis that the proposal of Municipal Services Associates, Inc. be accepted; and,

WHEREAS, the Video/Cable Coordinator has determined that this contract is inappropriate for competitive selection because of the ongoing work Municipal Services Associates, Inc. performed for many years.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposal dated April 30, 2003 submitted by Municipal Services Associates, Inc. to review and redraft the City of West Allis cable ordinance, draft a revised franchise agreement, and serve as technical advisor to the City during negotiation of a franchise agreement for the total net sum of \$57,460.00 be and is hereby accepted.

BE IT FURTHER RESOLVED, that the Purchasing/Central Services Division be and is hereby authorized to issue a purchase order for the aforesaid services.
