**RESOLUTION AUTHORIZING AND DIRECTING THE CITY ENGINEER TO
CHANGE THE NAME OF A PORTION OF S. SIX POINTS CROSSING BETWEEN
W. NATIONAL AVE. AND W. LAPHAM ST. TO S. 66TH ST.**

WHEREAS, the Board of Public Works has received a request from property owner Makers Row QOZB, LLC to change the name of a portion of S. Six Points Crossing between W. National Ave. and W. Lapham St. to S. 66th St.

WHEREAS, the requested change supports a future business prospect within Makers Row; the street name change affects only one property (tax key no. 454-9005-000) located at 1573 S. Six Points Crossing under the control of Makers Row QOZB, LLC.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the City Engineer is authorized and directed to change the name of a portion of S. Six Points Crossing between W. National Ave. and W. Lapham St. to S. 66th St.
