The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of October.

Incident reports:

Case #15-44005, 09/26/2015, 0230: 7731 W Becher St– Booster’s Bar (Late reporting)

On 09/26/2015, Officers took a theft report from Booster’s Bar. The victim stated he made contact with an employee at Boosters who viewed the security footage. The video shows his wallet sitting on the bar when a white male, in his 20’s steals his wallet off the bar and exits. The stills of the video were posted on WAPD social media. Two parties turned themselves in, including the stolen wallet. They both were cited for Theft.

Case #15-43720, 09/27/2015, 0232 hrs: 8824 W Becher St – Walleye Saloon (Late reporting)

On 09/27/2015, Officers responded to Walleye Saloon for a report of a male being struck in the face. A party stated he was struck in the face by an unknown party, causing swelling and a chipped tooth. The Offender was located and stated the other party was harassing his girlfriend and would not leave her alone. The Offender was arrested and issued a municipal citation for Battery. The bartender called in the assault. After seeing his doctor, the victim advised he needed surgery to have his broken nose reset and has 3 chipped teeth. The victim did not want the Offender charged criminally.

Case #15-44549, 10/02/2015, 2058 hrs: 9442 W National Av – Heartbreakers

On 10/02/2015, Officers responded to Heartbreakers for a Disorderly Conduct complaint. A patron was ejected from the premise and then tried to fight security staff. The party was

restrained by security staff until police arrived and he was arrested and issued a municipal citation for Disorderly Conduct.

Call #15-45539, 10/09/2015, 1958 hrs: 1902 S 68 St – Drunk Uncle

On 10/09/2015, Officers responded to the Drunk Uncle for a Theft complaint. The bartender called, stating he got into a physical altercation with a patron who entered the bar and ordered one drink. The bartender refused to serve him a second drink because he realized the patron was intoxicated. The patron refused to pay for the drink so the bartender took his cell phone as collateral. They began pushing and wrestling with each other. The patron took his phone back and left the bar. He then came back to the bar and gave the bartender money. Officers made contact with the patron and advised him not to return to the bar.

Call #15-45579, 10/10/2015, 0158 hrs: 6235 W National Av – McGuires Bar

On 10/10/2015, Officers responded to McGuires Bar for an intoxicated female passed out on the floor. Officers made contact with her. She could not answer basic questions and her speech was slurred and mostly unintelligible. West Allis Fire Dept responded and she was turned over to them. The bartender stated she came into the bar intoxicated and only had one drink at the bar.

Case #15-46711, 10/17/2015, 2233 hrs: 9033 W. National Av – JBeans

On 10/17/2015, Officers responded to JBeans for a report of a possible trouble call in regard to a female lying on the ground bleeding from the head. Investigation revealed a male and a female got into an argument outside of JBeans. During the argument, the male pushed the female onto the ground, causing her to hit her head. West Allis Rescue responded. She stated she had lost consciousness when she hit her head on the ground. She was highly intoxicated. The male party was taken into custody for DV Battery. The bartender stated they were never inside the bar. However, the Offender stated they had taken a cab from one bar to JBeans. While at JBeans, they got into a verbal argument, which traveled outside to the front of the pub.
