The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of November 2017

Incident reports:

<u>Case #17-044860 // 10 November 2017 at 2032hrs. // Spot Lite – 6424 W. Greenfield Ave.</u> NO TAVERN VIOLATION

Caller: Desiree Dickey – Employee / Offender

Disorderly Conduct & Resisting: On 11/10/17 at approx. 2032hrs, officers responded to Spot Lite at 6424 W Greenfield Ave for a report of robbery of a purse. Upon arrival the caller, Desiree A Dickey, F/W was very uncooperative with officers and began shouting at all patrons in the bar. She also attempted to push past officers, away from an officers grasp and eventually had to be decentralized. She was placed under arrest as was also later found to have been so intoxicated she had misplaced her purse. She was transported to the hospital and will be issued citations for DC and Resisting. Her local court date is set for 12/11/17 at 0830hrs.

Disorderly Conduct / Fighting: On 11/11/17 at approximately 2344 hrs. Officers were dispatched to Limanski's Pub, 8900 W. Greenfield Ave. for a report of a PDO hit and run. Investigation revealed, Myron B. Troutman (m/b) was involved in a physical altercation with three unknown Hispanic males and thrown to the ground. During the altercation Troutman suffered a small laceration to his right hand. The unknown males then entered a Grey Mazda CX-7 bearing WI registration MZ9107 and fled eastbound on W. Greenfield Ave., after striking a vehicle parked in the 1300blk of S. 89 St. Officers attempted contact at the registered owner's address with negative results. The offenders are described as 3 h/m's in their mid 20's all approximately 5ft 7-5ft 8 with an unknown clothing description. Contact has yet to be made with the owner of the fleeing vehicle and the 3 males have yet to be identified.

Disorderly Conduct: On 11/18/17 at approximately 0009 hrs. Officers were dispatched to Aris Sports Bar, 1657 S. 108 St. for a report of an intoxicated female refusing to leave the bar. Upon arrival, Officers located Tracy L. Giese (f/w seated on the floor of the bar. Tracy appeared to be highly intoxicated and had to be escorted outside. Officers walked Giese to the Days Inn lobby where she became belligerent and began to swear at Officers, causing a disturbance. Giese was placed into custody for DC and transported to the station for booking. Giese was booked, issued a citation, and held until sober.

Disorderly Conduct while Armed / Pointing & Aiming Firearm: On 11/19/17, at approx. 0133hrs, Officers responded to Harry O's, 6743 W. Lincoln Ave., for a report of a fight inside the bar and one person had a firearm. Investigation revealed that Adam L. Malmquist m/w got into an altercation with Kevin C. Pavich m/w. During the altercation, Adam removed a black Glock 42 .380 from his waistband, pointed it at Kevin briefly before handing it to his friend to hold. Adam left the bar after a brief physical altercation with Kevin and resumed possession of his Glock 42 and began to walk home. I located Adam walking in the alley behind 6707 W. Lincoln Ave. Adam diverted from the alley, behind this residence when he observed my squad and ditched his Glock which he admitted to doing. Adam's Glock was located and Adam admitted to possession and owning the Glock. Officers detected a strong odor of intoxicants emitting from Adam's breath, his eyes were red and glassy and his speech was slurred. Adam was subsequently arrested for DC while armed,

Going Armed while Intoxicated and pointing and aiming. This case will be reviewed by the DA's office on 11/27/17 at 0830hrs.
