Resolution relative to determination of Special Use Permit for Fusion Café, a proposed restaurant to be located within the multi-tenant building at 1427 S. 108 St.

WHEREAS, Rong Shi, d/b/a SL 100, LLC duly filed with the City Administrative Officer-Clerk/Treasurer an application for a Special Use Permit, pursuant to Sec. 12.42(2) and Sec. 12.16 of the Revised Municipal Code, to establish Fusion Café, a restaurant with outdoor dining at 1427 S. 108 St.; and,

WHEREAS, after due notice, a public hearing was held by the Common Council on June 19, 2012, at 7:00 p.m., in the Common Council Chambers to consider the application; and,

WHEREAS, the Common Council, having carefully considered the evidence presented at the public hearing and the following pertinent facts noted:

1. The applicant, Rong Shi, d/b/a SL 100, has offices at 1198 George Towne Dr., Pewaukee, WI 53072.
2. The applicant will occupy approximately 2,360 sq. ft. of the 4,000 sq. ft. two-tenant building at 1427 S. 108 St., West Allis, Milwaukee County, Wisconsin, more particularly described as follows:

All the land of the owner being located in the Northeast  $\frac{1}{4}$  of Section 6, Township 6 North, Range 21 East, City of West Allis, Milwaukee County, State of Wisconsin, describes as follows:

Beginning at the Northeast corner of Parcel 1, Certified Survey Map No. 3800; thence Northwesterly, 100.30 feet, along the West right-of-way line of South 108th Street; thence Westerly, 213.21 feet; thence Southerly, 100.00 feet; thence Easterly, 221.30 feet to the West right-of-way line of South 108th Street and Point of Beginning.

Tax Key No. 448-9999-004

Said land located at: 1427 S. 108 St.

3. The applicant is proposing to occupy an approximate 2,360 square foot portion of the two-tenant building for Fusion Café which will also utilize outdoor dining on the site.
4. The aforesaid premises is zoned C-3 Community Commercial District under the Zoning

Ordinance of the City of West Allis, which permits restaurants as a special use, pursuant to Sec. 12.42(2) and Sec. 12.16 of the Revised Municipal Code.

5. The subject property is part of a block along the west side of S. 108 St. between W. Greenfield Ave. and W. Lapham St., which is zoned for commercial uses. Properties to the north, south, east and west are developed for commercial uses.
6. The proposed development should not adversely contribute to traffic volumes or traffic flow in the area as the property offers off-street parking and is served by public transit.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the application of Rong Shi, d/b/a SL 100, LLC., to establish a restaurant with outdoor dining at 1427 S. 108 St., be, and is hereby granted on the following grounds:

That the establishment, maintenance and operation of the proposed use, with the imposition of certain conditions hereinafter set forth, reasonably satisfies the standards set forth in Secs. 12.16 of the Revised Municipal Code, so as to permit the issuance of a special use permit as therein provided.


BE IT FURTHER RESOLVED that said special use permit is granted subject to the following conditions:

1. Site, Landscaping, Screening and Architectural Plans. The grant of this special use permit is subject to and conditioned upon the site, landscape, screening and architectural plans approved on May 23, 2012, by the City of West Allis Plan Commission as provided in Sec. 12.13 of the Revised Municipal Code of the City of West Allis. No alteration or modification of the approved plan shall be permitted without approval by the Plan Commission.
2. Building Plans and Fire Codes. The grant of this special use is subject to building plans being submitted to and approved by the Department of Building Inspections and Zoning and by the Fire Department.
3. Restaurant Operations. The restaurant will be permitted to be used for dine-in, carry-out, drive-thru and outdoor dining as shown on the approved set of plans.
  - A. All exterior doors shall be kept closed to prevent sound/noise emissions into the adjacent neighborhood.
  - B. Excessive odors from cooking on premises shall be controlled within limits of current technology.
  - C. Excessive noise and vibrations shall not emanate from the building.
  - D. Employees shall inspect the site and immediate vicinity and pick up litter on a daily basis.
  - E. Exterior pest control shall be contracted on a monthly basis.

4. Hours of Operation. The hours of operation will be from 6:00 a.m. to 10:00 p.m., seven days per week.
5. Off-Street Parking. A total of twenty-two (22) spaces are required on site. Twenty-nine (29) parking spaces are provided.
6. Litter. Employees shall inspect the area and immediate vicinity and pick up litter on a daily basis. Refuse, recyclables, grease and other waste materials will be fully enclosed within an approved 4-sided structure to match the building.
7. Window Signage. Any building window signage shall not exceed twenty (20) percent of each window's area.
8. Marketing Displays. The use of pennants, special lighting, flags, streamers or other signage typically temporary in nature, hanging, floating or attached to a structure or vehicle shall not be permitted.
9. Refuse Collection. Refuse collection to be provided by commercial hauler and stored within a four-sided enclosure large enough to accommodate all outdoor storage of refuse and recyclable containers and/or compactor.
10. Pagers, Intercoms. The use of outdoor pagers, intercoms, or loud speakers shall not be permitted on site.
11. Sidewalk Repair. The grant of this special use is subject to compliance with Policy No. 2814 of the Revised Municipal Code relative to the City's sidewalk improvement policy as it relates to damaged, abutting sidewalk.
12. Outdoor Lighting. The grant of this special use is subject to all lighting fixtures being orientated and/or shielded in such a manner that no light splays from the property boundaries.
13. Noxious Odors, Etc. The use shall not emit foul, offensive, noisome, noxious or disagreeable odors, gases, or effluvia into the air. Mechanical systems shall be maintained to efficiently remove noxious odors.
14. Pollution. The use shall not cause any noxious or unwholesome liquid or substance or any dirt, mud, sand, gravel, or stone refuse or other materials to be deposited upon any public right of way or flow into any sanitary sewer, storm sewer, or water supply system, or onto adjacent properties.
15. Expiration of Special Use Permit. Any special use approved by the Common Council shall lapse and become null and void one (1) year from and after that approval if the use has not commenced, construction is not underway, or the owner has not obtained a valid building permit. An extension of these time limitations may be granted without a public hearing by the Common Council by resolution reauthorizing the special use in accordance with the following criteria:
  - A. The applicant requesting the extension shall complete a planning application available from the


terms and conditions and will abide by them.




