PART I. Subsection 12.41(2)(dd) of the Revised Municipal Code of the City of West Allis is hereby repealed.

PART II. Subsection 12.43(2)(1) of the Revised Municipal Code of the City of West Allis is hereby created to read:

12.43 C-4 REGIONAL COMMERCIAL DISTRICT.
