The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of August.

Incident reports:

Case #16-300587, 07/23/2016, 2230 hrs: Boosters West 7731 W Becher St

A party came into the police station to report he was assaulted at Boosters West. He stated a male approached his table and began helping himself to his food. The party told this male to leave his food alone and leave. The male became upset and punched the victim with a closed fist, on the left side of his chin. The punch caused pain and an approximate one inch laceration. The victim could not provide the name of any other witnesses, nor was he able to identify the Offender in a photo line-up. Therefore, no citations were issued.

Case #16-31472, 08/04/2016, 0038 hrs: 8423 W. Greenfield Av – O'Connor's Perfect Pint

On 08/04/2016, Officers responded to O'Conner's for a report of a male who injured his head falling off the bar stool. Officers located the State Fair carnival ride employee. He attempted to resist officers and was highly uncooperative. He was arrested for Disorderly Conduct and Resisting an Officer and transported to the House of Corrections, based upon the final commitment he held from last year's State Fair.

Case #16-33219, 08/13/2016, 0351 hrs: 5826 W. Burnham St – Rock Star Saloon

On 08/13/2016, Officers responded to Rock Star Saloon for an assault complaint. Contact was made with a female party who was bleeding from the mouth and had substantial swelling to both eyes and right cheek. She stated her children's father punched her in the face more than ten

times and choked her during an altercation that occurred in their home. The female ran to the Rock Star Saloon and yelled to patrons outside to call the police. The male party was arrested for Strangulation/Suffocation – Domestic Violence related and Substantial Battery – Domestic Violence related. The victim stated she and her husband had been drinking at Rock Star Saloon from 9pm until bar close. When they got home, he began arguing with her about relationship issues. The female stated her husband was very intoxicated and often gets violent when he drinks. The case was reviewed at the Milwaukee County District Attorney's Office and the male party was charged with Strangulation Suffocation and Battery – DV related.

Case #16-34090, 08/18/2016, 2310 hrs: 8924 W Schlinger Av – Shepherds Sports Lounge

On 08/18/2016, Officers were dispatched to Shepherds for a report of female parties fighting outside. A female party was observed smashing the windshield of a vehicle in the back parking lot of the bar. She disregarded Officers commands and attempted to run towards a male party. She was subdued with an ECD and taken into custody. She was issued local citations and released. Another female failed to identify herself and was arrested for Obstructing. She was on probation and a hold was placed on her.

Case #16-34418, 08/21/2016, 0245 hrs: 9442 W. National Av - Heartbreakers

On 08/21/2016, Officers responded to Heartbreakers for a vehicle collision. Investigation revealed a male party was drinking inside Heartbreakers prior to backing into another vehicle in the parking lot. The party was intoxicated and was arrested for OWI.
