





(DWA, Inc.) is requesting permission to use the public parking lot on the south side of Greenfield Avenue between 73rd & 72nd Streets behind Avant-Garde as a location to hold the **2**nd **Annual Downtown West Allis BID Merchants Appreciation Picnic on Wednesday, May 20, 2009 from 11:00am until 1:00pm.**

Our plans are to prepare the food at Avant-Garde and serve and enjoy it in the parking lot. In the past the DWA, Inc. has requested the assistance from the City of West Allis for parking restrictions and the use of signs and supplies to ensure event safety. We are grateful for your support and request the use of:

- "No Parking" signs placed in the public parking lot south of Greenfield Avenue behind Avant-Garde. We ask that parking in this lot be restricted from 6am until 2pm on Wednesday, May 20th.
