The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of April 2018:

### **INCIDENT REPORTS:**

#### CASE #18-011815// 2 April 2018 at 2108hrs// Rock Star Saloon- 5826 W Burnham St NO TAVERN VIOLATION

Caller: Joseph M Champeau- Witness

On 04/02/18, officers responded to Rock Star Saloon, located at 5826 W Burnham St, for a trouble call. Investigation revealed Ricardo Garcia Martinez, M/W was battered by "Danny," a M/W, approx. 30 years of age, wearing a stripped knit cap, a gray Milwaukee jacket, that may have left in a green smaller pick-up truck. Ricardo's glasses were damaged during the attack, and bar patrons believed "Danny" was the unprovoked aggressor. Officers suspect Daniel R. Rhoades, M/W due to a similar incident involving him. Further investigation and photo array to follow.

On 04/06/18 at approximately 2308hrs, officers responded to the Drunk Uncle at 1902 S. 68 St. for a trouble call. Investigation revealed, April J. Rieger, F/W and and Rachael C. Tovar, F/W refused to leave the establishment and caused a scene. Several witnesses stated Tovar damaged a glass cup and Rieger assaulted the bar owner. Tovar was arrested, cited, and released for DC. Rieger was in possession of a small amount of marijuana and drug paraphernalia. She was arrested, cited and released for DC-Battery and Possession of Drug Paraphernalia. The local court date for both is set for 05/07/18 at 0830hrs.

On 4/17/18 at 2211hrs officers responded to Boosters West, 7731 W. Becher St, for a weapons call in which an unknown male fled in a gray Dodge Challenger after displaying a silver handgun. Upon arrival I spoke with the bartender, Erica J. Schluenz, f/w who said a light skinned black male, with short curly hair, in his early 30s pulled up in front of the bar in a silver Dodge Challenger unknown plate. The man asked Erica if Manny or Chris were inside. Erica said Manny was not there, and she did not know who Chris was. The man displayed a large silver and black handgun with possibly an extended magazine, and told Erica "If you see Chris tell him I have this for him" before driving away east on W. Becher St. Erica said she did not recognize the man or the vehicle, and that the man never pointed the gun at anyone. Officers made contact with "Manny" identified as Emmanuel I. Silva-Stulo, m/w, who said he did not know who this person was, and does not know anyone who drives that type of vehicle. Investigation continues.

The pedestrian suffered lacerations and a dislocated shoulder. Officers waited at the listed address of 1234 S. 54 St. and the vehicle subsequently arrived. The driver, George R. Pezewski, stated he came from Tap City but did not strike anyone. George was impaired and was arrested for OWI GBH and Hit and Run GBH. George was conveyed to CJF. On 04/22/2018 at 0158 hours, a concerned caller reported an altercation outside of Bug N Out Tavern, located at 5630 W. Lincoln Ave. Investigation revealed an argument amongst family members regarding one of the members attempting to drive home intoxicated. Family refused to cooperate who the family member was who may be intoxicated. The allegedly impaired driver was GOA. I conducted a tavern check and found the business in compliance.

# <u>CASE #18-015613// 30 April 2018 at 2155hrs// Flappers- 7527 W Becher St NO TAVERN VIOLATION</u>

On 04/30/2018 at approx. 2200hrs, officers responded to Flappers located at 7527 W Becher St to investigate a check on the welfare of a female inside of the tavern. Upon arrival, contact was made with Valery A Heald F/W who was wondering in traffic on W Becher St in front of the business. Investigation revealed that Valery was not wearing shoes, was rambling about Burger King, and was unaware of her surroundings. It was determined that due to Valery's mental illness she was unable to satisfy lifes basic needs for nourishment, medical care, safety, or shelter. She demonstrated an inability to make competent decisions and appeared to refuse medication. Valery had been previously cleared at the Aurora West Allis Medical Center but was released shortly after transport. Valery was transported to the Milwaukee County Mental Health Complex where she was turned over to mental health professionals for an evaluation. Valery was accepted at the facility without incident.
