On 09/10/21 at 2316hrs. Officers responded to the Jock Stop for a report of a black male kicking the tavern's door. Investigation revealed, Kamariyon D. Mcdougle kicked the tavern's door and now it was not closing properly. Kamariyon left the scene prior to Officer's arrival and he was not located. Kamariyon was issued a DC citation and it was mailed to his residence.

On 09/12/21 at approximately 0158hrs. Officers responded to AWAMH for a report of an assault that had occurred at JC's Pub located at 8028 W National Ave. Rebecca J Lomis-Stephan and her daughter, Kaytlin C Lomis, went to JC's this evening and while there, a female bumped into Rebecca. Rebecca told the female, "Excuse me." A short time later, Kaytlin approached the unknown female and briefly spoke to her. The female then turned to Rebecca and punched her in the face and head several times. The unknown female was then kicked out of the bar. While on the patio, Rebecca was approached by the same female and the female pulled her hair.

Ultimately the female left and Rebecca asked the bartender to call the Police but they refused. Rebecca and Kaytlin left the bar and went to the hospital. Employees at the bar had no information on the incident. The offender is a F/W, blonde hair, early 30's, 5'3", skinny build, wearing a white dress or romper.

Officer Cooper Reports...

On 09/17/2021 at approximately 1337hrs. Officers responded to JC's Pub (8028 W. National Ave.) for a call that a customer assaulted the bartender. On scene I spoke with the bartender, Tori L. Schultz who stated a customer ID'd as Alina D Richmond and her boyfriend were cut off from buying more drinks because they were highly intoxicated. Alina slammed a glass of water on the bar, breaking it. Alina was arrested for disorderly conduct, booked, cited and given a courtesy ride to her residence. Court date is set for 10/25/2021 at 0830hrs.

CALLER: Tavern Check

Officer Dufek Reports...

On 09/24/21 at approximately 2355 hrs., while attempting to do a tavern check at Crooked Crow, 1309 S. 60 St., Officers observed a loud argument in the parking lot. Officers made contact with Caitlyn B. Montijo and her cousin Willis J. Murguia who were both highly intoxicated. Investigation revealed, Caitlyn had been involved in a verbal altercation with her boyfriend, whom she refused to identify, "Because she ain't no snitch," and had climbed on top of his vehicle as he was attempting to leave. Caitlyn was subsequently thrown from the vehicle and sustained an abrasion on her right thigh. Caitlyn advised she did not have a domestic relationship with her boyfriend and did not wish for anything to be done regarding the incident. After speaking with Caitlyn, Willis became highly argumentative, refused to leave the bar and was causing a disturbance while inside. Willis was arrested for DC, booked, cited and released with a local court date of 11/08/21 at 0830hrs.
