**RESOLUTION TO CONFIRM AND ADOPT THE REPORT OF THE CITY
ENGINEER CONTAINING THE SCHEDULE OF PROPOSED ASSESSMENTS FOR
IMPROVEMENT OF VARIOUS SIDEWALKS BY CONCRETE RECONSTRUCTION.**

WHEREAS, pursuant to Resolution R-2025-4251 adopted on October 21, 2025 and as provided in sec. 66.0703(5) of the Wisconsin Statutes, the City Engineer prepared and submitted a report for the improvement of the general area bounded by S. 108th St. to west city limits and south city limits to the union pacific railroad; and,

WHEREAS, the City Clerk gave due notice that the report was open for inspection at the Clerk's office and at the office of the City Engineer and that all persons interested could appear before the Common Council to be heard concerning the matters contained in the report and Resolution R-2025-4251; and,

WHEREAS, the Common Council met pursuant to the notice, and having considered the proposed improvements and the matters contained in the City Engineer's report, including the schedule of proposed assessments, the Common Council made no changes to the report.

WHEREAS, the properties against which the assessments are proposed are benefited, and the assessments shown in the report are true and correct, having been determined on a reasonable basis.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the report of the City Engineer relating to various sidewalk repairs in the general area bounded by S. 108th St. to west city limits and south city limits to the union pacific railroad, including the schedule of the proposed assessments, is approved.

BE IT FURTHER RESOLVED that the City Engineer is authorized and directed to prepare final plans for the improvements in accordance with the report and Resolution R-2025-4251.




