Dear Mr. Pertemer,

Mike Pertner followed-up with At Woldities

Art 'N Oddities, an Art Gallery located at 5833 W. Lincoln, is planning an outdoor art show, "The Lincoln Avenue Bazaar," on Saturday and Sunday, August 18th and 19th with alternate dates of August 25th and 26th. We are asking the help of your office to proceed. Meri Berghauer, Owner/Artist of Art 'N Oddities and Maryanne Harry PR Assistant, have met with Alderman Vince Vitale in a planning session. He indicated the need for several permits. We would like to use the 27' by 100' slab of concrete on the east side of the building to place 20 artists in 10' X 10' spaces, as well as closing 59th Street from the alley north to Lincoln Avenue in order to accommodate another 20 in 10' X 10' spaces for a total of 40 artists. The time frame for the street closure would be from 6:00am on Saturday, August 18th through the duration of the show Sunday evening August 19th at 7:00pm. After some discussion Mr. Vitale suggested temporary no parking signs for both sides of the street Friday evening, August 17th, in order to avoid an overnight parker that could complicate set up for early in the morning. We would like to leave the street blocked off during the overnight hours in case some of the artists would like to leave their tents up facilitating early morning setup. Any tent that is used will be weighted and not staked down. There are no homes involved on this area of 59th Street. There are many alternate routes available for resident access down the street.

Many of Art 'N Oddities artists are West Allis Artists. We feel it is a great way to showcase them as well as introducing new artists to the area. The neighborhood has been extremely receptive to the gallery for the last 6 years; I would think they'd enjoy the fun of an outdoor show.

In recap, we are requesting the closure of 59th Street at 6:00am August 18th to 7:00pm August 19th. including temporary no parking signs on both sides of the street from 8pm Friday night August 17th.
