Resolution to approve a Bargaining Unit Clarification Stipulation with the Wisconsin Federation of Nurses and Health Professionals, AFT, AFL-CIO.

WHEREAS, the Wisconsin Federation of Nurses and Health Professionals, AFT, AFL-CIO (Nurses Unit) filed a Bargaining Unit Clarification Petition dated November 11, 2005; and,

WHEREAS, the City and the Nurses Unit have resolved this matter and have agreed upon the terms of the attached Stipulation; and,

WHEREAS, the Administration & Finance Committee has reviewed the Stipulation and is recommending approval.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the attached Stipulation between the City and the Nurses Unit be and is hereby approved.

BE IT FURTHER RESOLVED that the Mayor be and is hereby authorized and directed to execute the aforesaid Stipulation on behalf of the City.

STIPULATION

Whereas the Wisconsin Federation of Nurses and Health Professionals, AFT, AFL-CIO (Union) has filed a petition with the Wisconsin Employment Relations Commission (Commission), docketed as Case #92, No. 65331, ME(u/c)-1159, seeking to accrete certain positions employed by the City of West Allis (City) in its Department of Public Health into the bargaining unit presently represented by the Union and described as, "All regular full time and regular part time professional registered nurses in the employ of the City of West Allis, excluding supervisory, managerial, executive, confidential and all other employees;" and

Whereas the Union and the City would like to resolve the issues raised by the Union's petition without the need for an evidentiary hearing;

Now therefore, the Union and the City agree as follows:

- 1. Upon execution of this Stipulation, the City agrees to recognize the Union as the exclusive bargaining representative for a unit described as, "All regular full time and regular part time professional Public Health Nurses, Public Health Specialists, and Community Health Nutritionists in the employ of the City of West Allis, excluding supervisory, managerial, executive, confidential and all other employees."
- 2. The Union agrees that Cheryl Davies, presently employed by the City as a Community Health Nutritionist, is not a "regular part time" employee within the scope of the bargaining unit described in paragraph (1), above, under the circumstances under which she is currently employed.
