SUMMARY

Officer Schrandt reports: *****DC - STATE FAIR INN - 8101 W. GREENFIELD AVE.*****

On 11/28/14 at 2106hrs, I was dispatched to State Fair Inn (8101 W. Greenfield Ave.) for WAFD medical units requesting PD. On arrival, I made contact with Edward Y. Kalashian (m/w, 01/06/51), who was in the WAFD ambulance being treated for burns to his feet and legs. Investigation revealed that while Kalashian was inside the men's room stall of State Fair Inn, he passed out while holding onto a lit cigarette. The cigarette subsequently set fire to Kalashian's shoes and pants. Kalashian woke up with his feet and legs in flames, called for help, and eventually the fire was put out by another patron with a fire extinguisher. Kalashian was transported to St. Mary's Hospital for treatment for the burns on his lower

On 11/28/14 at 2106hrs, I was dispatched to State Fair Inn (8101 W. Greenfield Ave.) for medical units requesting PD.

CONTACT WITH EDWARD Y. KALASHIAN

On arrival, I made contact with Edward Y. Kalashian (m/w, 01/06/51), who was in the WAFD ambulance being treated for burns to his feet and legs. I made contact with Kalashian and asked him what happened. Kalashian stated he was inside the bathroom stall, and thought he must have fallen asleep as he did not remember anything prior to waking up. Kalashian stated his pants were on fire when he woke up. I asked Kalashian if he was smoking inside the stall and he said no. At this time, I went inside to speak to other witnesses.

OFFICER OBSERVATIONS

Upon entering the bathroom, I observed a white chemical residue from the fire extinguisher covering the entire bathroom. I also observed burn marks on the stall door, and on the floor. A burned shoe was found on the bathroom sink. On the top of the toilet tank where Kalashian had been sitting, I saw a half full pack of cigarettes, and on the floor in front of the toilet, I observed a lighter.

CONTACT WITH ANDREW J. POTOIC

I made contact with the cook, Andrew J. Potocic (m/w, 03/06/72), who stated he remembered Kalashian entering the bathroom. Potocic remembered Kalashian being in the bathroom for "a long time," which he estimated to be over 30 minutes. At some point after Kalashian entered the bathroom, Potocic heard someone call for help as he was walking past the bathroom. Potocic opened the bathroom door and saw Kalashian exit the stall with his shoes and pants on fire.

Potocic called for help, and Joseph F. Jansky (m/w, 11/30/60), who is a retired firefighter, came into the bathroom. Potocic and Jansky attempted to put out the flames with water from the sink. When that was unsuccessful, Potocic ran and got a fire extinguisher. Potocic gave the fire extinguisher to Jansky, who extinguished the flames. Potocic called the police shortly thereafter.

CONTACT WITH JOSEPH F. JANSKY

I made contact with Jansky, who confirmed Potocic's claim of Kalashian being in the bathroom in excess of 30 minutes. Jansky remembered Potocic calling for help, and then seeing Kalashian with his lower body consumed in flames. Jansky stated he put out the flames with the fire extinguisher Potocic gave him, after the two of them were unable to put out the flames with water from the sink.

I made contact with the owner of the bar, William L. Potocic (m/w, 08/19/42), who stated he did want Kalashian to receive a citation based on the damage and the mess created in the bathroom.

Potocic did not give Kalashian consent to smoke in the bathroom and cause a fire.

Kalashian was booked out of custody with booking # 14-005617. He was mailed citation #M140056171 for causing fire with tobacco materials. He was assigned a municipal court date of 12/29/14 at 0830hrs.

CASE DISPOSITION

On 11/28/14, Edward Y. Kalashian fell asleep with a lit cigarette inside of a bathroom stall at State Fair Inn (8101 W. Greenfield Ave.). Kalashian's shoes and pants ended up starting on fire, which was eventually put out by another patron. Kalashian was ultimately cited for causing fire with tobacco materials. He was assigned a municipal court date of 12/29/14 at 0830hrs.
