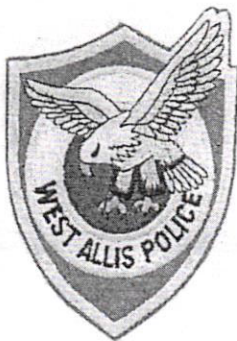

NARRATIVE

At the time of this investigation I was wearing my WAPD issued body camera, which was functional and activated. The body worn camera footage was categorized. See video recording for precise details as the following is a summary based off little or no review.

OFFICER SANTA CRUZ MEDINA REPORTS

On 07/04/19 at approximately 0050hrs, I conducted a Tavern Check at Sallywood. Upon my arrival, I observed that there were approximately six to eight patrons outside smoking. One of the individuals that was smoking identified himself as Shane E. White, m/w ■■■■■ and he advised that he was the security guard of the bar.

CONTACT WITH SHANE E. WHITE

Shane was advised that I was conducting a tavern check. Shane was asked if he is armed security for the bar and he advised he was not. Shane was also advised to have the patrons outside to go inside as they were being loud and I did not want neighbors to complain. Shane understood and had the patrons go inside if they were being loud.

Shane had nothing further to add to his statement.

CONTACT WITH ROBERT L. ANDERSON

After speaking with Shane, I went inside the bar and spoke with the owner of the bar, Robert L. Anderson, m/w ■■■■■ Robert was advised that I was conducting a Tavern check and needed to see the business liquor license. Robert complied and

handed me the business Class B liquor license (18-00002551), which indicated that it was issued on 07/19/18 with a License Period starting on 07/01/18 and ending on 06/30/19, and expiration date of 06/30/19. Based on the fact that the liquor license indicated that it was expired, I asked him if he had renewed his license, which he stated he did. Robert stated that he did not have the new liquor license with him as the new license had not yet arrived.

Robert later handed me a letter from the City of West Allis which indicated that he had to renew his liquor license on 04/30/2019 and a receipt with a payment to the city on 05/14/19. Robert advised that the receipt was the payment to renew his liquor license, however the receipt did not have in detail what the payment was for. Robert also admitted that he renewed his liquor license late and the city made him pay a late fee. I asked Robert if he had any other documents to support that he renewed his license and he advised that he had given all the other paperwork the to his book keeper.

Based on the fact that his Class B Liquor License was expired and Robert having no proof that his license was renewed, I advised him to stop serving the patrons and to close the bar. Robert stated he understood and complied. I later advised Robert that he was going to get a citation for serving alcohol while his liquor license is expired.

It should be noted that as I was inside the bar, I observed that there was approximately 35 patrons inside the bar with majority of them with an alcoholic beverage.

Robert had nothing further to add to his statement.

BARTENDING LICENSE

While on scene I spoke with Frank M. Kiewit, m/w [REDACTED] Frank stated he was a bartender at Stallywood and provided me with his bartending license (19-560).

CITATION ISSUANCE

Based on the fact that Stallywood was serving alcohol while its liquor license was expired, I issued the owner, Robert citation 1S804DZZ8Q.

CASE DISPOSITION

On 07/04/19 at approximately 0050hrs, I conducted a Tavern Check at Stallywood. Investigation revealed that the business was open and serving alcohol while its Class B license is expired. I made contact with the owner, Robert L. Anderson and had him close the business. Robert was issued a citation for serving alcohol while having an expired Class B license.
