**RESOLUTION ACCEPTING THE WORK OF STATE CONTRACTORS FOR
TRAFFIC CALMING AND PEDESTRIAN IMPROVEMENTS AND
AUTHORIZING AND DIRECTING SETTLEMENT OF SAID CONTRACT IN
ACCORDANCE WITH CONTRACT TERMS OF 2025 PROJECT NO. 3 FOR FINAL
PAYMENT OF \$2,405.85**

WHEREAS, State Contractors has completed their contractual obligations in accordance with the plans and specifications therefore, attested by the approval for payment by the City Engineer.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the work of State Contractors (2025 Project No.3) for intersection traffic calming, including the installation of concrete curb and gutter, concrete sidewalk, ADA compliant curb ramps, signing, pavement marking, and sodding at W. Becher St. from S. 84th St. to S. 87th St. is accepted, and the proper City officers are authorized and directed to make settlement with the said contractor in accordance with terms of said contract.




