The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of January 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case 09-000128, 01/05/09 at 0006hrs. J.P.'s Hat Trix Bar, 5826 W. Burnham St.

On the above date and time officers were called to J.P.'s Hat Trix Bar in regards to a bar fight. Two female parties were involved in a fight over a pool game. During the fight several other patrons joined in the fight. The two main combatants were arrested for Disorderly Conduct. One party involved also received two stitches to the top of his head. The bartender on duty called the police.

Case 09-000348, 01/12/09 at 0205hrs. Las Palmas Restaurant, 6007 W. Burnham St.

On the above date and time officers while on patrol observed patrons inside of Las Palmas drinking at the bar after hours. **While retrieving names from the fifteen or so patrons in the tavern the bartender on duty Luis A Mares-Lira, M/H, 09/07/72 fled the scene. Records show this same party was cited on 09/01/08 for serving underage parties at Las Palmas.** Party was mailed a citation for allowing patrons to remain on licensed premises after hours.

Case 09-000821, 01/28/09 at 0028hrs. Network Tavern, 9541 W. Cleveland Ave.

On the above date and time officers responded to a man with a gun call at the Network Tavern. The complainant who is a bar manager stated that a fight had occurred in the tavern and that the

main combatant threatened to shoot several patrons and then drove by the bar and pointed a gun at the manager and bartender. Party was arrested and charged with 2 counts of disorderly Conduct While Armed. The gun turned out to be an airsoft pistol.

Tobacco and Alcohol Compliance checks;

On January 18th West Allis PD did tobacco compliance checks at 10 businesses throughout the city. All 10 stores were in compliance.
