The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of February.

**Incident reports:**

**Case #15-5274, 02/04/2015, 2215 hrs: 6001 W. Madison St – Kokopelli’s Pub & Grub**

On 02/04/2015, Officers responded to Kokopelli’s Pub and Grub to investigate a report of a male being disorderly and refusing to leave the business. Officers made contact with the male, who was intoxicated and verbally uncooperative with officers. While trying to obtain his name, he became physically uncooperative. He was directed to the ground where he continued to fight with officers. An Electronic Control Weapon was deployed into the small of his back. He was then restrained. He was also found to be in possession of a marijuana pipe. He was arrested and cited for Disorderly Conduct and Resisting.

**Case #15-5766, 02/07/2015, 2244 hrs: 6300 W. Lincoln Av. - Johnny Hammers**

On 02/07/2015, Officers responded to Johnny Hammers for a subject wearing a mask, a winter coat and jeans, chasing people. Officers made contact with a male party running through an alley with a large pipe wrench. He advised he was trying to help a friend change a tire. The investigation revealed he had been kicked out of the bar earlier and had returned to fight an individual. This caused a disturbance amongst bar staff. He was arrested for disorderly conduct while armed. The Offender was highly intoxicated.

**Case #15-5880, 02/08/2015, 1634 hrs: 7216 W. Lincoln Av - Jimmy B’s Trails End**

On 02/08/2015, Officers responded to Jimmy B’s Trails End for a report of a person lying in the roadway. Upon arrival, Officers found a male lying beside his vehicle, which was parked in

front of Jimmy B's. He stated he slipped on the pavement, fell and struck his head. The bartender reported he served the male 4 standard beers, but did not believe him to be intoxicated. The street/walk area was free from snow and was well salted. The roadway was wet, but not icy. Officer did not observe any ice or snow near the male's vehicle. He was conveyed to AWAMC for lacerations to his forehead and nose.

**Case #15-5809, 02/08/2015, 0236 hrs: 9440 W. National Av – Heartbreakers**

On 02/08/2015, Officers responded to Heartbreakers for a trouble call. Upon arrival, Officers were directed to the west side of the building to meet with security, who was forcefully escorting a male out of the building. Security stated the male party was attempting to leave with an unidentified girl in a vehicle. The girl did not want to go with him and security stepped in. The male returned to the club and attempted to punch the security guard. He was extremely loud, disruptive and combative with security. He was highly intoxicated. He was arrested and during a search of his belongings was found to have a small Ziploc baggie filled with 14 corner cut baggies containing marijuana. He was cited for Disorderly Conduct and Possession of a Controlled Substance.

**Case #15-6484, 02/12/2015, 1552 hrs: 7216 W. Lincoln Av - Jimmy B's Trails End**

On 02/12/2015, Officers responded to Jimmy B's Trails End for a report of a highly intoxicated bar patron who may be having a medical issue. The bartender stated the male appeared normal and not overly intoxicated upon entering the bar at 11am. He had two or three mini pitchers, which is equivalent to approximately nine beers and two shots of Rumplemintz. The party was transported to the hospital.

**Case #15-6505, 02/12/2015, 1739 hrs: 5732 W. Mitchell St – Tap 58**

On 02/12/2015, Officers responded to Tap 58 to assist the U.S. Department of Revenue in a cash register seizure of funds, due to back taxes. Officers met with the Field Compliance Revenue Agent who performed the seizure with a valid warrant. The bar owner was present and cooperative with the process.

**Case #15-6695, 02/13/2015, 2214 hrs: 7400 W. Becher St – Barnecks**

On 02/13/2015, Officers responded to Barnecks for a trouble call of multiple parties fighting. Upon Officers arrival, there were no parties fighting and everyone in the bar was calm. The bartender advised a male party was intoxicated and threatening to fight people in the bar. He yelled at several patrons, but there was nothing physical.

**Case #15-7833, 02/22/2015, 0021 hrs: 6500 W. Greenfield Av – 6500 Bar**

On 02/22/2015, Officers observed a physical altercation in front of 6500 Bar. A male party was screaming profanities and became resistive. He was placed in handcuffs, continued to resist and refused to enter the squad car. He was highly intoxicated. The party had an open case for Domestic Violence and was arrested for disorderly conduct, resisting and bail jumping.

### SUMMARY

#### PO ISKANDARANI REPORTS:

#### **\*\*\*Disorderly Conduct / Resisting / Possession of Paraphernalia\*\*\***

On 02/04/2015 at approx. 2216hrs, officers responded to Kokopelli's Pub and Grub located at 6001 W Madison St to investigate a report of a male being disorderly and refusing to leave the business. Officers subsequently made contact with a male later identified as Scott J Braaten, M/W, 05/18/1962, who was intoxicated and verbally uncooperative with officers. While trying to obtain his name, Scott became physically uncooperative. Scott was directed to the ground where he continued to fight with officers. Due to continued active resistance, I drew my Electronic Control Weapon (ECW) and deployed it in the small of his back. Officers were then able to place Scott in restraints. Scott was also found to be in possession of a marijuana pipe.

**NARRATIVE****PO ISKANDARANI REPORTS:****INITIAL INFORMATION:**

On 02/04/2015 at approx. 2216hrs, officers responded to Kokopelli's Pub and Grub located at 6001 W Madison St to investigate a report of a male being disorderly and refusing to leave the business. Upon arrival, I assisted officers already on scene by acting as a cover officer for Lt Pye who was speaking with the subject in front of the door leading into the business.

**OFFICER OBSERVATIONS:**

During my initial contact with the subject, later identified as Scott J Braaten, M/W, 05/18/1962, I could tell Scott was highly intoxicated and agitated with police contact. Scott had his left side towards Lt Pye and his back towards me. As I asked Scott to provide his name and information, Scott slowly turned around counter clockwise and started spelling his last name.

Scott speech was heavily slurred and he was speaking softly making it difficult to hear. I asked Scott to repeat the spelling of his last name. Scott started screaming "did I fucking stutter?" tensing his entire body and closing both of his fists. Scott took 2-3 small steps forward toward me.

As a result of Scott's aggressive behavior, his high level of intoxication, his unwillingness to cooperate with officers, Scott was directed to the ground. As Lt. Pye moved in to direct Scott to the ground, I believed Scott was going to assault officers on scene.

**RESISTING AN OFFICER:**

PO Mussatti, PO Keiley, Lt Pye, and I moved in to try and secure Scott in handcuffs. Officers advised multiple times to "stop resisting" and "put your

hands behind your back". Scott continued to struggle and actively resist officer's attempts to place his hands behind his back. Scott was lying face down on the sidewalk with his hands tensed and locked under his body.

As I tried to bring his right arm out from under his body, he continued to actively struggle and resist. I could feel resistive tension and could tell Scott was not going to willingly bring his hands behind his body. Scott continued display resistive tension in his arms as we tried to bring his right arm out from under his body. Scott arms and hands being under his body prevented officers from being able to place him in handcuffs. Throughout the entire struggle officers were issuing commands to "stop resisting" and to bring his hands behind his back.

While I worked to free Scott's right hand, I observed PO Mussatti directing focused strikes towards his lower left back and abdominal area. Officers were still struggling to place Scott in handcuffs.

Based on my observations and the fact Scott continued to struggle, disregard our commands to stop resisting, and not place his hands behind his body I drew my "Electronic Control Weapon" (ECW) and placed it in the small of his back. I deployed the device causing Scott's body to "lock up".

Immediately after the five (5) seconds was over, Scott stopped actively resisting officers and we were able to place him in handcuffs. No additional force was used as the threat was stopped and Scott was secured in handcuffs.

**MEDICAL CLEARANCE:**

After placing Scott in handcuff restraints, officers immediately radioed for dispatch to send medical services to our location for an examination. Upon arrival, Scott was physically cooperative and stated he did not require medical attention.

Scott ultimately declined medical treatment from WAFD and stated he did not want to be transported to the hospital.

After concluding the medical screening, I conducted a thorough search of Scott before placing him in the back of my squad vehicle for transport to the station. Located in his right pants pocket, I located a small gray pipe that based on my experience, I believed to be used for smoking marijuana. I confiscated this item and secured him in the back of my squad car.

**TRANSPORT:**

Scott was transported back to the West Allis Police Department without incident.

**MIRANDIZED STATEMENT:**

On 02/04/2015 at 2340hrs, while in Interview Room A of the West Allis Police Department, I read Scott his Miranda Warnings off Departmental Directive 42.016. Scott declined to speak with me regarding this incident. This was audio recorded on an Olympus DS-2200 Digital Voice Recorder and saved on a departmental media card (P14-1) and stored in the Technical and Forensics Bureau.

**BOOKING:**

Scott was arrested, printed, and booked under booking #2015000513 for Resisting an Officer, Disorderly Conduct, and Possession of Drug Paraphernalia. Scott was issued three municipal citations, M150005132, M150005133, and M150005131 with a local court date of 03/16/2015 at 0830hrs. Scott switched from being cooperative to verbally uncooperative throughout the booking process. Scott also refused to sign the PR bonds for the Disorderly Conduct and Resisting an Officer citations.

**PROPERTY:**

The small gray marijuana pipe was placed on property under property #15-00831-1.

**CASE DISPOSITION:**

On 02/04/2015 at approx. 2216hrs, officers responded to Kokopelli's Pub and Grub located at 6001 W Madison St to investigate a report of a male being disorderly and not leaving. Upon arrival, officers made contact with Scott J Braaten M/W 05/18/1962 who was ultimately taken into custody for the multiple offenses. After concluding the booking process, responsible party Joseph M Behmke, M/W, 01/01/1961, arrived on scene and took custody of the highly intoxicated offender.

**NARRATIVE**

**Lt Pye Reports 02/04/2015**

I responded to this call as I was in the area. I was the first to arrive and entered the bar. I observed the offender, Scott Braaten, seated at the bar. There were approximately 6 other patrons in the bar. The bartender told me that Braaten was belligerent and had been kicked out of the bar numerous times tonite and kept returning and being disorderly. See Officer Mussatti supplement for complete statement of the bartender.

I escorted Braaten outside the bar and asked him what was happening tonite and he stated that "he started shit and doesn't know why". Additional officer arrived at this time. Braaten stated that he did not have any identification on him so I asked him to verbally provide his name. He spelled his last name unintelligably and he was asked to repeat it. He began to scream and swear and refused to provide his name. I advised him at this time that he was under arrest for disorderly conduct and grabbed his right arm to turn him away from me. He immediately attempted to pull away from me and face me while swearing at me so I decentralized him onto the sidewalk. Braaten tucked his arms underneath him and would not put his arms behind him as ordered. Officer Iskanderani deployed a Taser drive stun to Braaten's back, see Officer Iskanderani supplement.

Braaten was ultimately secured in handcuffs, medically treated by WAFD and then transported to WAPD for processing.

Officer Mussatti reports...

INITIAL ARRIVAL

Upon arriving to Kokopelli's Pub and Grub, I observed several officers out with the male party (Scott Braaten) who had refused to leave the business when asked. While they were talking to Braaten, I entered the business to speak with the bartender, Brian T. Williams, M/W 11/28/73.

BRIEF STATEMENT OF BRIAN T. WILLIAMS - WITNESS

I asked Williams what happened. He said Braaten was being loud and belligerent immediately upon entering the bar. Williams could tell he was drunk, and advised Braaten he could not serve him. Williams ultimately told Braaten to leave the bar, and he left but returned through the back door. After he returned through the back door, Braaten refused to leave, and continued to be disorderly inside the bar.

RESISTING/USE OF FORCE

After I received a brief statement from Williams, I started to walk towards the front of the business to advise assisting officers. As I was walking towards the clear glass door, I observed people rolling on the ground, one of which appeared to be an officer. I immediately exited the business, and it appeared the officers were trying to gain control of Braaten while on the ground.

I positioned myself to the left of Braaten, and he was refusing to put his arms behind his back. His arms were by his chest, and I grabbed his left arm. I yelled at Braaten to put his left arm behind his back. While I was holding onto his arm, I felt his arm tense, and he was pulling against me in an

attempt to keep his arm by his chest. I punched the left side of Braaten's abdomen in attempt to get his arm behind his back. After I struck him, I continued to try to pull his arm back, and at this point, Officer Iskandarani tased Braaten. After Braaten was tased, I was able to pull his arm completely behind his back to complete the handcuffing.

**FURTHER STATEMENT OF BRIAN T. WILLIAMS**

After Braaten was arrested, I returned inside the bar to obtain a more detailed statement from Williams. Williams observed Braaten walk into the business, and said when he entered, he was immediately loud. Braaten yelled, "Where's the party?" and, "What the fuck?" He said Braaten appeared intoxicated due to him walking in, partly stumbling. Williams said he would not serve him drinks, due to him already being intoxicated. Upon telling Braaten that he would not be served alcohol, Braaten became angry and started to yell at and insult Williams. I asked Williams what Braaten was saying. Braaten called him a delinquent and said he did not know how to do his job, along with other insults.

While Braaten was yelling and insulting Williams, Williams tried to calm him down and asked him to leave. Braaten left the bar, and he immediately returned by entering through the back door of the business. Williams again advised him he had to leave the bar. Braaten continued to yell at Williams, and he refused to leave. Braaten said he was calling the police, opened his phone, and then he closed the phone and said he called the police. Williams advised Braaten he was going to call the police. Williams called the police, and ultimately officers arrived on scene. Williams said there were approx. seven people inside the main area of the bar, and there were several people in the back of the bar. He said most of the customers saw the disturbance Braaten created.

**DRUG TESTING**

At the station, Officer Schultz handed me a small plastic baggie containing a green leafy substance that based on my training and experience I believed to be marijuana.

I took all of the (14) fourteen baggies to the Forensics and Technical Bureau, removed the substance from the packagings and placed it on a digital scale. I observed a reading of approximately 11.1 grams. I took a small sample (the total weight remained unchanged), placed it in a test tube and performed the Duquenois-Levine Test. This is a test that I have been trained in the administration of and am familiar with. I began the test by adding 10 drops of reagent #3 (Duquenois) to the sample in the test tube and shook it gently and observed a slight yellow color in the solution. I then added to the solution 10 drops of reagent#7 (Hydrochloric Acid), shook the solution gently and observed a purple color and some fizzing. Concluding the last step of the test by adding a 20 drops of reagent # 9 (Chloroform) and observed a separation, I observed a distinct purple color in the bottom layer of the test tube indicating the presence of THC (tetrahydrocannabinol) and positively identifying the substance as marijuana.

I packaged the marijuana in an evidence envelope and placed it on property under number 15-000895.

**NARRATIVE****INITIAL OBSERVATIONS****Officer Mathy reports...**

On 02/22/15 at approximately 0021hrs, I was parked in a fully marked City of West Allis squad, in the 6400blk of W. Greenfield Ave. waiting for a tow for a separate incident. While parked I observed a physical altercation between several individuals, including the offender, David J. Scalf M/W 12/28/87. It appeared as if several individuals were attempting to direct Scalf away from the entrance of 6500 bar. I immediately drove to the intersection of S. 65 St./ W. Greenfield Ave. and illuminated my emergency lights and activated my siren briefly. After doing so the individuals separated from each other and I ordered the group to stay out front as I initiated contact with Scalf.

**DISORDERLY CONDUCT/ RESISTING AN OFFICER- DAVID J. SCALF (OFFENDER)**

I made contact with Scalf, who was identified by WI drivers license. Scalf was screaming when I made contact with him and I requested he calm down. Scalf yelled that he was just punched in the face. I observed a small superficial laceration on the left side of his face below his eye and I asked Scalf if he wanted medical attention and he said he did. I requested a medical unit to respond to assess Scalf. While waiting for the medical unit to respond I attempted to speak with Scalf regarding the incident.

Scalf continued to yell, be profane, and began to walk away from me. Due to the physical altercation that took place, including Scalf's apparent involvement, I told him to walk back toward my location in an effort to continue my investigation. Scalf did not comply and I initiated contact with his right arm to escort him back toward the incident location. As I escorted Scalf he was still screaming "I got fucking punched!" I told Scalf again to stop screaming and informed him that he may be arrested if his behavior continues. Up until this point, I was on scene by myself and several other individuals involved in the potential assault were in my vicinity. Scalf behavior caused me to direct any attention away from the original incident to attempt to reason with Scalf's belligerent behavior. As I was in contact with Scalf it was apparent that he was highly intoxicated as his speech was slurred, he had a strong odor of intoxicants emitting from his breath, and his eyes were red and glassy.

Once I escorted Scalf back toward our original position, I felt resistive tension in Scalf's right arm as he clenched his fist and he began to pull his arm toward the center of his body, away from my position. I told Scalf to stop resisting and to stop yelling. At this time Officer Otto arrived on scene. Due to Scalf's refusal to stop yelling and using profane language, his inability to follow

simple commands, and his resistive actions, I escorted him to the east side of the building to stabilize him with the assistance of Officer Otto. I told Scalf that he was under arrest and placed him in handcuffs. Scalf did not resist as I placed handcuffs on him and he relaxed his arms. I informed Scalf that he was under arrest and I began to escort him toward my squad. I informed Scalf that he was under arrest for disorderly conduct and he continued to yell "I got hit, this is wrong," or words similar to that effect. As I was searching Scalf he pressed and pushed his hips toward my direction, flexed his right arm and began to turn his body toward me. Based on Scalf's resistive behavior, I stabilized his upper body against the squad and ordered him "stop resisting." Scalf temporarily complied.

I searched Scalf once back at my squad and I told him to sit inside. Scalf did not comply and continued to yell about the previous incident. I informed Scalf that other Officers were investigating the incident that occurred prior to my arrival and I ordered him again to sit in the squad. Scalf still did not comply and I attempted to place him in the squad by directing his upper body into the seat. Scalf pushed his upper body and torso away from my squad and toward my direction. I then pulled his upper body down by grabbing his back and head which allowed me to successfully place him in the squad.

Shortly after placing Scalf inside the squad the medical unit arrived on scene. I informed Scalf prior to escorting him to the ambulance that he needed to be cooperative. Scalf was very emotional and stated he would be cooperative and began to cry. Once in the ambulance Scalf was advised by medical personnel that he had a small superficial scratch under his left eye. Scalf continued to talk over the medical personnel and continued to tell me that "you got the wrong guy." I informed Scalf that I believed he was in a physical confrontation, however, his actions during my contact with him was why he was under arrest. Scalf stated "I am sorry I resisted," and he continued to request he not be under arrest.

Scalf refused to go to the hospital and I transported him back to the WAPD for booking.

**ON SCENE STATEMENTS**

I was later informed by Officers that witness statements reflected Scalf reportedly hurt his face while falling on an icy snow bank and was yelling racial slurs while he was consuming alcohol. Video surveillance was requested from the 6500 Bar and is still pending.

Once at the WAPD, I checked CCAP to see if Scalf had any open criminal cases. I discovered that Scalf was on bail for Milwaukee County case number 2014CM004909. The case details reflected that Scalf was to maintain absolute sobriety as a condition of his bail. While in the booking room Scalf admitted to consuming alcohol since approximately 2100hrs. I asked Scalf if he would be willing to submit to a Preliminary Breath Test (PBT) and he said he would. Captain Marks administered the PBT which estimated Scalf's BAC at .20 g/210L. After the test was completed Scalf again stated "I am sorry I resisted." Scalf varied between being argumentative, screaming, and pleading that we not arrest him.

**BOOKING OF OFFENDER**

Due to Scalf continuing to yell and not follow simple instructions, I placed him in a cell while I completed the booking process. While in the cell, Scalf was hitting the cell door and continued to scream that he was falsely arrested. Shortly after I placed Scalf in the cell, Captain Marks spoke with him briefly. Scalf requested medical attention for his injuries and an ambulance was requested a second time. Scalf stated he wanted to be transported to the Hospital for medical evaluation and I escorted him to the ambulance. Once inside the ambulance Scalf continued to yell and stated "I hope you get killed in the line of duty."

I booked Scalf under booking number 15-000894 for disorderly conduct, resisting and bail jumping. I completed municipal citation number M150008942 for Disorderly Conduct and municipal citation number M150008941 for Resisting an Officer.

**MEDICAL CLEARANCE/ RESISTING AN OFFICER/ CHAPTER 51**

Sgt. Tillman monitored Scalf while he was being medically cleared. While at the Aurora West Allis Medical Center (AWAMC), Scalf made suicidal statements and was determined to be a chapter 51/ED by Sgt. Tillman. Additionally, Scalf resisted again while at the Hospital.

Tillman informed me that Scalf should be issued an additional citation for resisting an Officer for his actions at AWAMC. I completed municipal citation M-102348 for resisting an Officer. an Apprehension request for Scalf was completed and I included his municipal citations in the apprehension request, which were to be placed with his property when he is

**INITIAL CALL**

On 02/22/15 at 0021 hours, officers were dispatched to 6500 W. Greenfield Avenue for a disorderly conduct. Officers on scene arrested David J. Scalf (M/W 12/28/87) for disorderly conduct, bail jumping, and resisting arrest. On this date, I was assigned front desk duties at the police station. Officer Mathy requested I meet him in the WAPD booking room to assist with Scalf.

Scalf was very uncooperative with officers during the booking process. A PBT revealed Scalf's BAC was 0.20. Scalf later complained of chest pain and wanted medical attention. An ambulance was requested and Scalf was transported to Aurora West Allis Medical Center. Due to Scalf being uncooperative with officers and paramedics, I rode in the ambulance to the hospital. Once at the hospital, I handcuffed both of Scalf's hands to his hospital bed.

**CHAPTER 51 / CONTACT AT HOSPITAL**

While the hospital staff was treating Scalf for his possible injuries, he stated, "I don't want to live no more." When the nurse asked Scalf how he would harm himself, Scalf said, "Whatever I can find around here I will stick in my heart."

During my limited contact with Scalf to this point, I only knew him as David. I asked Scalf for his last name and date of birth; he said, "Fuck you, I want my lawyer." I then observed Scalf clench his left hand and slide it under his body. I walked from Scalf's right side, around the foot of the hospital bed, and stood by his left side. Scalf pushed his left hand further under his body. Due to Scalf's recent statement wanting to stab himself in the heart, and Scalf's reluctance to show me his left hand, I believed he acquired an object and was concealing it in his left hand.

I told Scalf to show me his left hand, he then slid his body closer to the left side of the bed, further covering his left wrist and hand. I grabbed his left forearm and told him to show me his hand; he pushed his hip against my hands. I pushed on Scalf's hip and told him again to show me his left hand; he just pushed back at me and said, "Fuck you." I delivered one focused strike to Scalf's left upper leg; he then moved to his right and displayed his open left hand. When Scalf moved to the right, I could see under his body and

did not observe any objects. I then let go of Scalf's left arm and walked to the foot of the bed.

Scalf began to scream at me and yelling "You assaulted me!" I attempted to explain to Scalf I was concerned he has something in his hand he could use to harm himself, but he kept yelling profanities at me. Two nurses entered the room and began to try to speak to Scalf, but he began to yell at them. Scalf told the nurses I punched him in the leg and the chest. I stepped into the doorway of the room and moved the privacy curtain so Scalf could not see me; I could still see the nurses from my position. I informed the doctor of Scalf's suicidal statements and requested he contact MCMH to inform them of this incident. The doctor stated he would attempt to have the MCMH mobile team respond to speak to Scalf. At this point, Scalf began to calm down but was still using profanity.

Scalf eventually calmed down and I was able to remain in the room. Scalf continued to use profanities toward me at a reasonable volume. I was seated in a chair to Scalf's left at the foot of his bed; he put both of his feet on the left rail of the bed and said, "I hope you like stinky feet." Scalf then lifted his left foot in the air, flatulated, and said, "How do you like that?"

A medical technician (Ryan) entered the room and stated he was going to take Scalf to get a CT scan to check for possible injuries. I followed Ryan as he pushed Scalf's bed to the CT scan room. Scalf began to yell profanities at me and hospital staff again. I informed the hospital staff I was not comfortable removing the handcuffs from Scalf without more officers present. Ryan pushed Scalf back to his room in the emergency area of the hospital while I waited for more officers to arrive.

Officer Martin and Officer Schneider arrived at the hospital and remained with me and Scalf as Scalf had his CT scan. Scalf continued to be uncooperative with hospital staff and would not remain still during his scan. Scalf would shout at officers, then cry. After several attempts by hospital staff, Scalf successfully completed the CT scan and was pushed back to his room in the emergency area. Officer Martin and Officer Schneider later left the hospital.

Scalf calmed down and I was able to carry on a conversation with him. Scalf told me about his prior drug and alcohol addictions, and about his relationship with his father. Scalf's father recently had a heart problem and was transported to the hospital. Scalf relapsed tonight because he was upset about his father's recent medical condition; to cope, he went to the bar to drink alcohol. Scalf said he knew the owner of the bar and he got his drinks for free. Scalf stated he felt betrayed by his friend (bar owner) because his friend did not defend him at the bar. Scalf paused as if he wanted me to say something; I reminded Scalf he requested his lawyer and I could not speak to
