**RESOLUTION ACCEPTING THE ARBITRATOR’S DECISION IN THE MATTER OF  
THE INTEREST ARBITRATION BETWEEN THE WEST ALLIS PROFESSIONAL  
POLICE ASSOCIATION AND THE CITY OF WEST ALLIS FOR THE 2022-2025  
COLLECTIVE BARGAINING AGREEMENT**

**WHEREAS**, the current labor agreement with the West Allis Police Association ended on December 31, 2021; and

**WHEREAS**, the City and West Allis Police Association were unable to reach a negotiated settlement for a successor agreement; and

**WHEREAS**, the City and West Allis Police Association participated in an Interest Arbitration, pursuant to Section 111.77 Wis. Stats., which requires the arbitrator to select the final offer of one of the parties and to issue an award incorporating that offer without modification; and

**WHEREAS**, the Arbitrator selected the terms of the City's final offer which, among other things, encompassed a four-year period from January 1, 2022 through December 31, 2025; and

**WHEREAS**, the Administration Committee has reviewed the Arbitration Decision and City's final offer and accepts/approves the terms of such for the successor agreement.

**NOW THEREFORE**, BE IT RESOLVED by the Common Council of the City of West Allis that the attached Arbitration Decision and City's final offer are hereby approved.

BE IT FURTHER RESOLVED that the proper City officers and representatives be and are hereby authorized and directed to execute the aforesaid Arbitration Decision on behalf of the City in the form of a new four-year Labor Agreement for the period of January 1, 2022 through December 31, 2025.
