Pursuant to the Wisconsin Plant Closing and Mass Layoff law (Wis. Stat. 109.07) and the federal Worker Adjustment and Retraining Notification ("WARN") Act, we are providing you with this notice that Roundy's Supermarkets, Inc./Mega Marts, LLC will be permanently closing its Pick 'n Save West Allis retail store located at 11111 W. Greenfield Ave., West Allis, WI 53214. The closing will occur on November 5, 2014. All employees will be released. This closing affects 68 employees.

The job titles of positions to be affected and the number of affected employees in each job classification are on Exhibit A, attached hereto, and incorporated herein.

The union that represents bargaining unit employees at this store is the United Food and Commercial Workers Union Local 1473 ("Local 1473").
