

Officer Schneider Reports:

INITAL CALL FOR SERVICE

On 02/16/2014 at 0120hrs,Officers responded to Paulie's pub, 8031 W. Greenfield Ave for a report of a possible disorderly conduct, regarding a female harassing a band member. Prior to arriving on scene, dispatch advised that the female left in Silver Honda, WI Plate#232-TUV, westbound on W. Greenfield Ave. Officers located the vehicle and conducted a traffic stop; I responded to the bar. I arrived on scene and spoke with the bouncer Daniel D. Anderson M/W 02/18/1983.

OFFICER OBSERVATIONS

I entered the back room of the bar, where the band was located. I observed the room had been cleared out and the band was packing up their equipment. On a table in the middle of the room, I observed the remains of a broken beer bottle and spilled beer. I observed more broken glass on the floor underneath the table.

CONTACT WITH DANIEL D ANDERSON - WITNESS

Anderson stated he was working at Paulie's as a bouncer. He stated he was behind the bar when one of the waitresses came up to him and asked him to help with a situation. He was informed there was an irate female in the back room, harassing a band member, later identified as Robert R. Gayle M/B 03/17/1969. Anderson stated as he entered the back room her heard a loud commotion.

Anderson heard a female, later identified as Colette A. Fredrick F/B 05/08/1968, yelling at a male. Anderson stated he observed the female grab a bottle of beer and smash it on a table. He stated the female then threw the remaining broken half of the bottle at Gayle, who was standing by the stage. Fredrick then attempted to get close to Gayle. Anderson stepped in and pulled Fredrick away from Gayle. He stated she then left the bar out the back door. He said she sat in her car, WI Plate#232-TUV, for approximately 5 minutes before leaving.

CONTACT WITH ROBERT R. GAYLE - VICTIM

Gayle stated he was playing with his band at Paulie's when Fredrick came into the bar. He stated they dated in the past but have never lived together and don't have any children in common. He stated she came up to him and began arguing with him. He stated, "She was making a scene." As Gayle was at the DJ booth she came up to him and grabbed his phone. Gayle told her to give it back and attempted to reach for it. As this happened Fredrick hit him in the face, scratching him, (I observed a faint scratch mark underneath Gayle's right eye). Once she hit him in the face he pushed her away from him.

Gayle told Fredrick not to touch him and give his phone back. Gayle stated he followed Fredrick away from the DJ booth and grabbed her in an attempt to get his phone back. Fredrick tried pushing Gayle away. Gayle and Fredrick went back and forth pushing each other and Gayle was eventually able to get his phone back. Gayle went back to the DJ booth where Fredrick followed him. He stated she began yelling in his face and threw his laptop on the ground. Gayle told Fredrick not to touch his property.

Fredrick went back to her table and continued to yell at him from there, causing a disturbance. He stated she grabbed a beer bottle and smashed it on the table. He said she then threw the broken half at him. Gayle stated the bottle missed him and smashed on the ground by the stage. He stated the bouncer then came in and separated them. Fredrick then left the bar.

ARREST DECISION / BOOKING INFORMATION

Based on the witness statements and Fredrick's behavior inside of Paulie's, she was taken into custody for Disorderly Conduct. Fredrick was transported to WAPD for booking. She was booked, issued a citation and released. For more information in regards to the booking process, see Officer Agor's supplement.

Officer Agor reports...

INITIAL CALL

On 02-16-14 at 0120 hours, officers responded to the area of Paulie's Pub, located at 8031 W. Greenfield Ave., for a report of a disorderly black female harassing a band member. Dispatch informed officers the black female left the location in a silver car.

INITIAL CONTACT WITH COLETTE A. FREDERICK (OFFENDER)

While traveling eastbound through the intersection of W. Greenfield Ave and S. 84th St., I observed a black female driving a silver Honda, going westbound through said intersection. I completed a u-turn at said intersection and followed the vehicle. I stopped the vehicle, bearing WI license plate #232-TUV, on the 8700 block of W. Greenfield Ave., and made contact with the operator, identified by her WI driver's license as Colette A. Frederick (F/B 05-08-68).

ARREST DECISION

CONVEYANCE AND BOOKING OF COLETTE A. FREDERICK (OFFENDER)

I conveyed Colette to the West Allis police station and booked her under booking #14-000761, for Disorderly Conduct.

IN CUSTODY STATEMENT OF COLETTE A. FREDERICK (OFFENDER)

On 02-16-14 at approximately 0236 hours, after the booking process was complete, I obtained a recorded statement from Colette. The statement was recorded using Olympus Digital Recorder P17 and media card P17-1 to record the interview. Before beginning the questioning, I read Colette her Miranda Rights, all of which she stated she understood. Colette waived his rights and agreed to answer questions without legal counsel. The following statement is a brief overview of what she said:

Colette reported she did have an altercation with a band member, and through a bottle at him. Colette admitted she should have walked out of the pub before it got as heated as it did.

I concluded this interview on 02-16-14 at approximately 0245 hours.

Officer Otto reports:

INITIAL RESPONSE/OBSERVATIONS

On 2/16/14, at approx. O120hrs, Officers responded to Paulie's Pub, 8301 W. Greenfield Ave. for the report of a female harassing a band member. As I entered the area of the bar where the incident took place, I observed a broken bottle and shards of glass on a table.

STATEMENT BY ARIANNA L. STESSL-CONTACT

On scene, I spoke with Ariana L. Stessl, (f/w, 4/16/95) who is an employee at Paulies. Ariana stated she was folding napkins and silverware when she was alerted by a female yelling loudly. She walked over to where she heard the noise and observed a black female, later identified as Colette A. Frederick, (f/b, 5/8/68) on the ground with a male, standing over her and 2 other parties trying to separate them. Eventually security for the bar had gotten involved and was escorting Colette out of the building.

While being escorted out of the building and past a table, Colette grabbed a glass beer bottle smashed it on the table, and threw a piece of the broken glass in the direction of the male party she was involved in the altercation with. Ariana advised that the broken piece of glass had struck a ceiling lamp that was located on north side of the back room and not the other party involved.

At no time did Ariana observe anyone strike, punch, or push another person. While speaking to Ariana, it was obvious she had not consumed any alcoholic beverages on todays date.

STATEMENT BY EILEEN M. BAMMERT-WITNESS

On scene, I spoke with Eileen M. Bammert, (f/w, 4/23/69), who stated she was dancing to the music of the band when she observed a black male and black female arguing. All that Eileen saw was the black male stick his hand in the black females face and push her. Eileen tried to intervene by grabbing him by the hood and attempted to pull him out. All of a sudden there were too many people around so she decided to get out of the way.

While speaking with Eileen, I detected a moderate odor intoxicants emitting from her breath and her speech was slightly slurred.
