

#### NARRATIVE

#### INITIAL CALL FOR SERVICE

On 7/15/13 at 0155hrs, while on patrol near the intersection of S 71 St and W National Ave, I was flagged down by a citizen who stated there was a very intoxicated hispanic male harassing people outside of Studz Pub (6833 W National Ave). When I arrived on scene I observed a hispanic male, later identified as Joel Beltran-Coyolt (M/H 11/11/88) stumbling around in the street in front of Studz Pub, near a Taxi Cab.

#### ON SCENE OBSERVATIONS

I made contact with Joel in front of Studz Pub and escorted him off the street and sat him down on the front steps of the bar. I asked for Joel's identification and he stated he did not speak english. I asked him again and he fumbled through his wallet and gave me a MATC student card. I asked Joel if he had any altercation with patrons at the bar and mumbled something I could not understand. Joel then fell forward and laid on the sidewalk. I instructed Joel to sit up and he ignored me. I sat Joel up and placed him in handcuffs. Another patron, who wanted to remain anonymous, told me to speak with the bar back of the bar, Anne C. Lopez (F/W 4/14/84), because Joel had an altercation with her earlier. I spoke with Anne inside the tavern.

#### ON SCENE STATEMENT OF VICTIM: ANNE C. LOPEZ

Anne stated about 20 minutes prior to my arrival, Joel was inside the bar and made several inappropriate comments to her. Joel told Anne he was going to fuck her. Anne stated she had seen Joel in the bar before and he usually gets very intoxicated and causes problem. Anne wanted him arrested for the inappropriate

#### ON SCENE STATEMENT OF CONTACT: REBECCA A. HAGMANN

Rebecca S. Hagmann (F/W 10/20/84) was bartending this evening and stated Anne told her Joel was harassing her but Rebecca never actually observed the incident. Rebecca showed me her bartender's license which was valid.

A tavern report was filled out for this incident as is attached to this report.

#### ARREST OF OFFENDER

Joel was handcuffed, searched and transported to the station for the booking process for Disorderly Conduct - Local.

#### BOOKING INFORMATION

Joel was mugged, fingerprinted and booked under booking #13-003253 for Municipal Disorderly Conduct. Joel was issued a municipal citation (M130032531) for this offense and held until sober.

Due to Joel's extreme impairment, he was unable to give an in custody statement.

#### CASE DISPOSITION

On 7/15/13 at 0155hrs, Officers responded to 6833 W National Ave for a suspicious activity complaint involving a very intoxicated male harassing customers at the bar (Studz Pub). On scene I made contact with Joel Beltran-Coyolt (M/H 11/11/88) who was indeed very intoxicated and uncooperative with officers. Witnesses stated Joel was harassing customers and staff at the bar. Joel was arrested for municipal Disorderly Conduct, cited and released from the station.

## STATEMENT BY ANN C. LOPEZ-CONTACT

Anne C. Lopez, (f/w, 4/14/84) stated she is a bartender at the business. There was a male party who was highly intoxicated, later identified as Joel Beltran-Coyolt, (m/h, 11/11/88) who was inside of the bar and was bothering customers. Joel was sitting in the bar and had his fly open which was partially exposing himself and wouldn't close it. Anne asked another patron to ask Joel to close his fly which he did not do. Eventually Joel was outside still being belligerent. Anne was attempting to get Joel to leave the area and had pushed Anne approx. 7 times in her breast area and chest. Joel eventually fell to the ground and was held down until he calmed down. Joel then attempted to remove a stop sign post from the ground but was unsuccessful. Shortly after this happened, Officers arrived on scene.
