**WHEREAS**, Max Meinerz, submitted a Certified Survey Map to combine two existing parcels located at 7020 W. National Ave. and 15\*\* S. 71 St. into one parcel; and

**WHEREAS**, with the grant of this Resolution, the Common Council grants a 6-month extension of time to record the map and its documents with the Milwaukee County Register of Deeds Office.; and
