RE: City Attorney's Report of Claim

Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (6)(a) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be denied:

#### Robert and Sharon Jerominski - Amount: \$128.00

This is a claim for damage to a front picture window at 8742 West McMyron Street in the City of West Allis on June 9<sup>th</sup>, 2008, when a City-owned tree was knocked down due to a storm on June 7<sup>th</sup>, 2008. The tree was lying across the road, which prompted a City crew to cut up and remove the tree between June 7<sup>th</sup> and June 9<sup>th</sup>, 2008. At some point after the City crew left the scene on June 9<sup>th</sup>, 2008, the claimants noticed that their front picture window was broken and felt that the City crew did the damage when removing the tree. The claimants had the window repaired and filed a claim against the City on July 22<sup>nd</sup>, 2008.

Our investigation into this claim indicated that the tree, which had fallen from the storm, as well as the crew who had performed the clean-up work were nowhere near the claimants' front window at any time. The pictures submitted by the claimants of the break in the window look like that of a ball or some kind of round object. No member of the City's crew knows anything about this incident other than being told by the claimants that the window was broken. The claimants did not see the window break as a result of the work performed by the crew; rather, the claimants are assigning blame simply because the tree fell and the City crew was in the area around the time the window was broken. There simply is no proof whatsoever that the City did any damage in this case.

Based upon the above, it is the recommendation of the City Attorney's Office to deny this claim pursuant to the provisions of Wisconsin Municipal Claims Statute 893.80.


