The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of December 2017

**Incident reports:**

**Case #17-048065 // 03 Dec 2017 at 1318hrs. // Lucky Chance Tavern – 6139 W. Beloit Rd. NO TAVERN VIOLATION**

**Caller: Kelly Schey - Employee**

**Disorderly Conduct:** On 12/03/17, officers responded to Lucky Chance Tavern, 6139 W Beloit Rd, for a male/female altercation. Investigation revealed Amber Hritz assaulted an unknown male patron, and was disorderly inside the tavern. The unknown male left prior to officers' arrival, and officers were unable to identify the male party involved. Amber was located in the area, and was cited for disorderly conduct. Amber signed a PR bond on scene, and a municipal DC ticket was later mailed to her.

**Case #17-048885 // 09 December 2017 at 02012hrs. // Bug N Out – 5630 W. Lincoln Ave. NO TAVERN VIOLATION**

**Caller: Amy E. Burns – Owner**

**Report for Record:** On 12/09/17 at 0212hrs, officers responded to Bug N Out at 5630 W. Lincoln Ave. for a male party who was non-responsive but breathing. Officers made contact with Jeremy J. Roth, M/W [REDACTED], who had been hunched over the bar. He was highly impaired and could not answer basic medical questions. The bar owner, Amy E. Burns, F/W [REDACTED], stated at approximately 0100hrs, he came out of the bathroom and within two minutes he passed out sitting at the bar. Officers located a white powdery substance on the top of the toilet bowl tank,

and later testing was inconclusive for opioids. Nothing illegal was located on Roth, who was conveyed to AWAMC for treatment. A report for record and tavern report were generated.

**NO TAVERN VIOLATION**

**Caller: Michael Draper – Employee and father of juvenile involved in this incident**

**Suspicious Activity / Report for Record:** On 12/16/2017 at approximately 1732hrs, Officers responded to Riviera Lanes, located at 8600 W Greenfield Ave, for a report of suspicious activity.
