When I succeed in receiving a reduction in sanitation expense and your MMSD markup you will have to do the same for all single one income household owners in your discriminating community. So who will pay up the difference or the loss?

FACT: for several years my water meter consumption did not exceed 6.0 ccf. There is no one in my house twelve to fourteen hours a day. But your minimum amount has increased every year.

FACT: According to your provided web site I obtained confirmation that majority of my neighbors and other areas have water meter consumption of 22 to 24 ccf. There does not have to be public hearing for you people to explain this illogic to me.

FACT: My struggle with epilepsy has relapsed, my needed sleep has been reduced, my driving license were suspended due to your behavior onto me, my blood pressure has multiplied, my interest and value in life. This is where attorneys and individuals like SCOTT POST come up with terminology like 'MENTAL DISSTRESS' that allows people to get away with multiple DUI's and violence in domestic or family household situations leading to lessened or dropped charges. Look at the drug houses you permit. This is what SCOTT POST studied in years of so called law school.
