Description of Proposal

The following is a modification of the Resolution No. 25347 adopted March 7, 2000 and approved on March 10, 2000 for the former Goody's Restaurant also known as Trudy's Restaurant located at 8929 West Becher Street.

- 1.) Restaurant Area. The floor area within the existing building will be utilized as follows: 3,200 square foot Joy's Wok. Seating for ninety-nine (99) patrons will be provided.
- 2.) <u>Hours of Operation</u>. Hours of operation shall be between 10:00 A.M. to 10:00 P.M. Sunday through Thursday and 10:00 A.M. to 11:00 P.M. Friday and Saturday.
- 3.) Off-Street Parking. Number of on-site parking spaces provided shall be at least forty-five (45) including two (2) handicap spaces.
- 4.) <u>Litter</u>. Employees shall inspect the site and immediate vicinity and pick up litter on a daily basis.
- 5.) <u>Employment</u>. The maximum number of employees per shift shall be twenty (20).
- 6.) Restaurant Operations. The restaurant will be utilized for a sit down (dine in), counter service, carry out and delivery of oriental style food. "No" alcoholic beverages will be offered.
- 7.) Window Signage. Window signage shall not exceed twenty percent (20%) of any window's area.
- 8.) <u>Exterior Signage</u>. All exterior signage will be as per city code.
