The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of October.

Incident reports:

Case #14-8721, 10/01/2014, at 2332 hrs: 6851 W. Beloit Rd, Shamrox Bar

On 10/01/2014, at 2332 hrs, Officers responded to 6851 W. Beloit Rd, Shamrox, for a report of people fighting. Two male parties got into a physical altercation over one of them disrespecting a female patron in the bar. The main Offender was arrested for Battery, cited, booked and released. The licensed bartender advised he is the one who called the police.

Case #14-8817, 10/05/2014, 0215 hrs: 5906 W. Burnham St – Drunken Duck

On 10/15/2014, at 0215 hrs., an Officer was in the area of 5900 W. Burnham St when she heard loud shouting. Officer observed a large group of people in the middle of the street and they appeared to have just had a physical altercation. Investigation revealed the verbal altercation began inside the Drunken Duck Tavern and it was later carried outside and turned into a physical altercation. Three Offenders were arrested for Disorderly Conduct on scene and another party, who was no longer on scene, was mailed a citation for Disorderly Conduct.

Case #14-9076, 10/13/2014, 0040 hrs., 9442 W. National Av – Heartbreakers

On 10/13/2014, at 0040 hrs., Officers responded to 9442 W. National Av., Heartbreakers, for a report of a trouble call in regards to three people fighting in the parking lot. The verbal altercation began inside the bar and it became physical outside when a male party punched a female in the mouth. He fled the scene prior to Officers arrival and was mailed a local citation for Battery.

Case #14-9098, 10/13/2014, 0730 hrs., 5906 W. Burnham St - Drunken Duck

On 10/13/2014 at 1630 hrs., a female came into the station to report the owner of Drunken Duck has touched her inappropriately. The investigation revealed there are four employees who have complained of similar activity. The party is not the owner, rather his daughter owns the Tavern, However, he has a Class I Bartender's License #15-156. He was arrested and the case is set to be reviewed at the Milwaukee County District Attorney's Office on 11/11/2014

Case #14-9263, 10/18/2014, 0045 hrs., 11904 W. Greenfield Av - Brass Monkey

On 10/18/2014, at 0045 hrs., Officers responded to 11904 W. Greenfield Av, Brass Monkey for a male pinned to the ground by bouncers who threatened harm with a gun. The party arrived at the bar asking for cigarettes and was turned away. He then stated he was a CCW holder and began to reach into his bag. Witnesses tackled him and held him down until the Police arrived. The party was cited for Disorderly Conduct and transported to CJF on several warrants.

Case #14-9265, 10/18/2014, 0051 hrs., 6833 W. National Av – Studz Pub

On 10/18/2014, at 0051 hrs., Officers responded to 6833 W. National Av, Studz Pub for a party slamming his head into the bar top, punching himself in the face and stating he wanted to kill himself, as he was escorted out of the bar. Officers made contact with the employee, who stated she heard the bartender ask the party to leave the bar, stating the party was belligerent and highly intoxicated. Officers made contact with the party at a residence. Another party at the residence charged at Officers. He was subsequently tased and arrested for resisting and drug paraphernalia. The party from the bar was arrested for Disorderly Conduct and warrants with the Milwaukee County Sheriff's Office. He was also transported to the Milwaukee County Mental Health, under Chapter 51, for suicidal statements.

Case #14-9720, 10/30/2014, 2201 hrs., 6833 W. National Av - Studz Pub

On 10/30/2014, at 2201 hrs., Officers responded to 6833 W. National Av, Studz Pub for an intoxicated male damaging the business window. The party was upset the bartender would not serve him alcohol. He left the business and punched the outside window. He was arrested for CDTP, booked, issued a municipal citation and WAFD took him for treatment to his injured hand.

Call #14-48789, 11/01/2014, 2035 hrs: 6200 W. Greenfield Av, Six Points Pub & Grill

On 11-01-14 at 2035hrs, officers observed a large gathering of motorcycles and full-patch outlaw motorcycle gang members from numerous clubs, coming and going from Six Points Pub and Grill, 6200 W. Greenfield Ave. An orange Camaro was also observed pulling up to the bar, either picking up or dropping off parties, and squealing its tires loudly as it left the area w/b on Greenfield Ave. There have been ongoing citizen complaints regarding the bars in that area of Greenfield Ave, regarding excessive noise due to vehicles and bar patrons. Officers responded to the bar, where two motorcycles were observed parked on the grass on city property. Officers

entered the bar to advise the motorcycle owners to move their bikes to a parking spot near the bar, or on to the street. While inside the bar, officers were met by bar owner, Douglas M. Ross, M/W 11-06-61. Ross seemed agitated and was very inquisitive of officers' presence in the area. Ross explained he was hosting an "All Saints Day" party for the numerous outlaw motorcycle gangs in the area in his establishment. When the Officer asked Ross if we could check to make sure he had a licensed bartender on staff, he became very upset with officers and reluctant to comply. Ross allowed officers to come into the bar; however, he turned off all of the music and made a scene inside of the bar, calling all of the patrons (well over fifty - with outlaw motorcycle gang insignia/patches) attention to the two officers inside of the bar. Ross began yelling that the police wanted to do a compliance check, "but it was not a big deal (sarcastically)." Ross continued to rant about the police presence and was confrontational and disrespectful. A patron, with Outlaw MC patches eventually approached Ross, telling him to calm down and to comply with officers' request, reminding him that our requests were not a big deal. As a whole, it was clear that Ross was resistive to the police presence inside and outside of his bar. Ross made a point to get the Officer's name off of her uniform and while officers were outside, several parties inside of the bar were videotaping the officers.
