#### NARRATIVE

#### COMPLIANCE CHECK OUTLINE

On 12/17/14 from 1700 to 1900hrs I conducted a tobacco compliance check at 14 randomly selected businesses that have a license to sell tobacco products. This check was completed through the use of a 16 year old male, Darien R. Kielley, M/W 11/23/98. Kielley entered each of the randomly selected businesses and attempted to purchase a pack of Newport cigarettes without providing any identification.

I advised Kielley if the sales clerk asked him for identification, he should immediately leave the business. I provided Kielley with \$20.00 from the WAPD Crime Prevention fund for the attempted purchases.

Prior to beginning the compliance check, I confirmed Kielley did not have any identification on his person. A photograph was taken of Kielley with a department issued digital camera, and the photograph was secured onto a WAPD media card to document his appearance on the day of the compliance check. The media card was later secured in an envelope and placed in the Forensics and Technical Bureau.
